














Source-Drain Diode Forward Voltage



On-Resistance vs. Junction Temperature




**Threshold Voltage**

T<sub>A</sub> - Ambient Temperature (°C) Current Derating\*\*, Junction-to-Ambient







### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Power Derating\*, Junction-to-Ambient



Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Case
