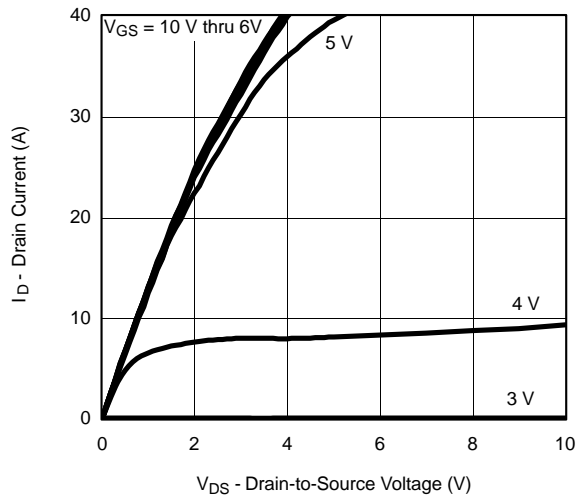

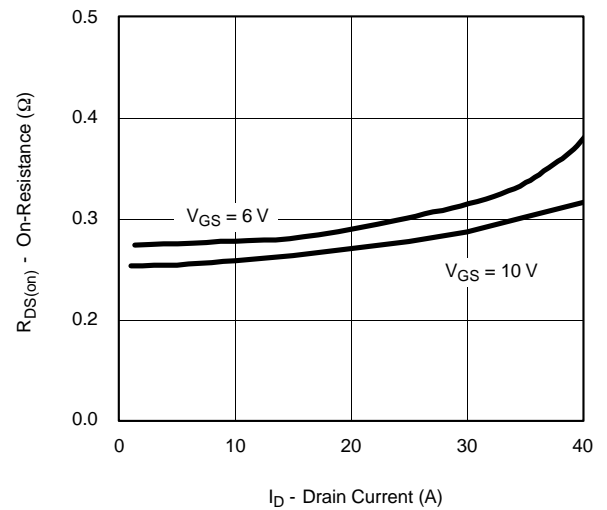

vs. Case Temperature



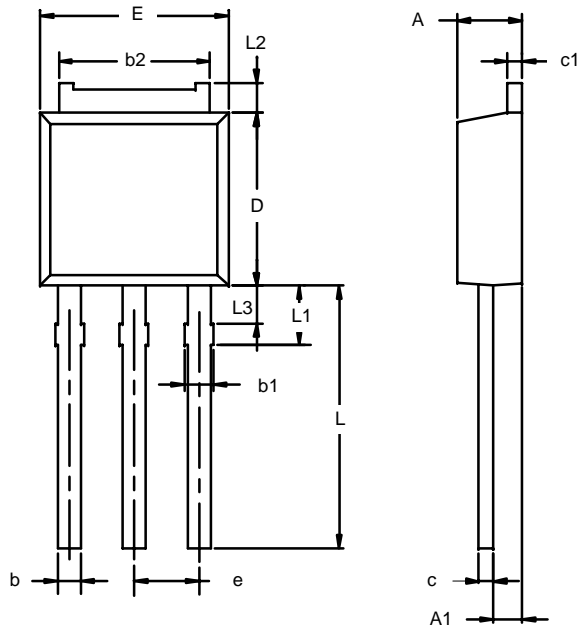
