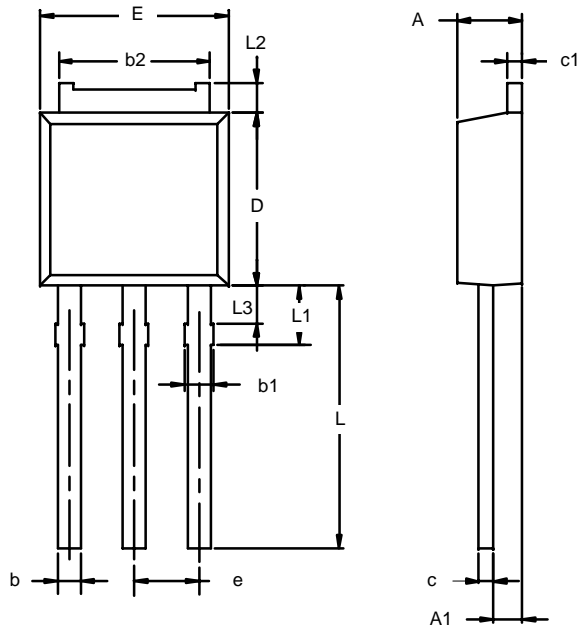
**Maximum Avalanche Drain Current vs. Case Temperature**
