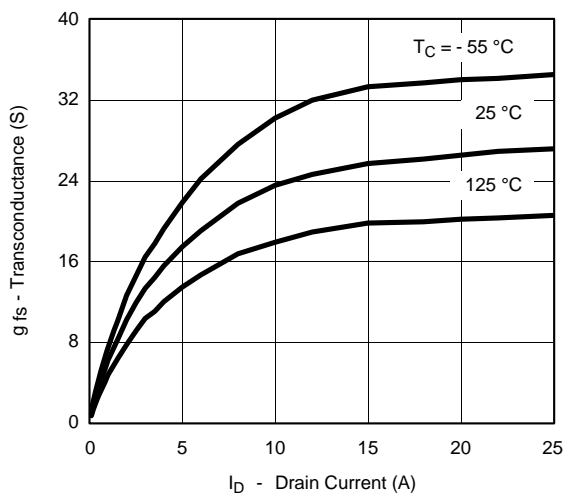

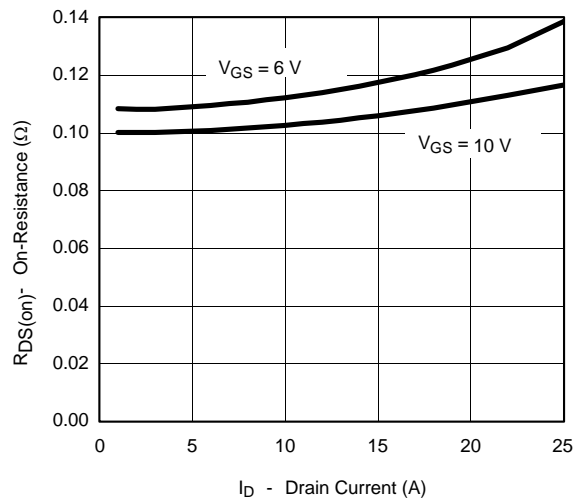

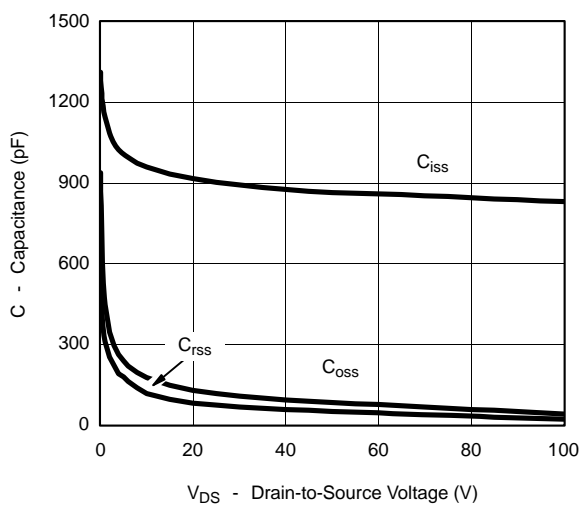
**Transfer Characteristics**

**On-Resistance vs. Drain Current**

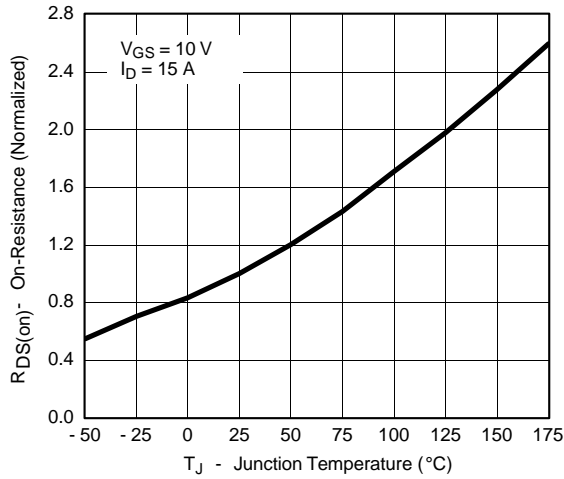


**Capacitance**

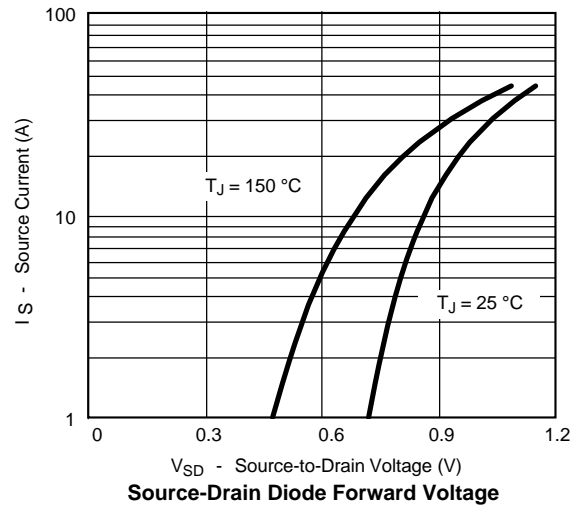

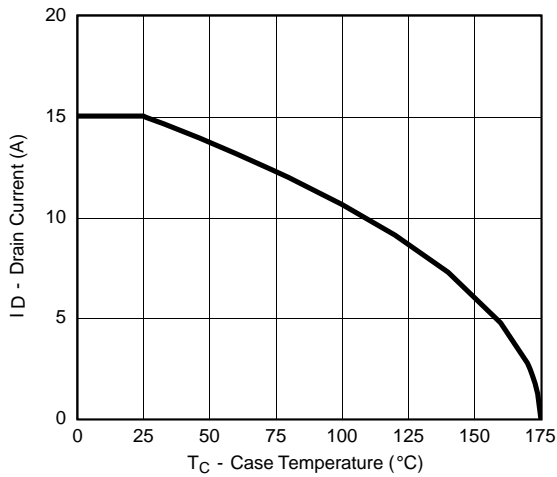


On-Resistance vs. Junction Temperature

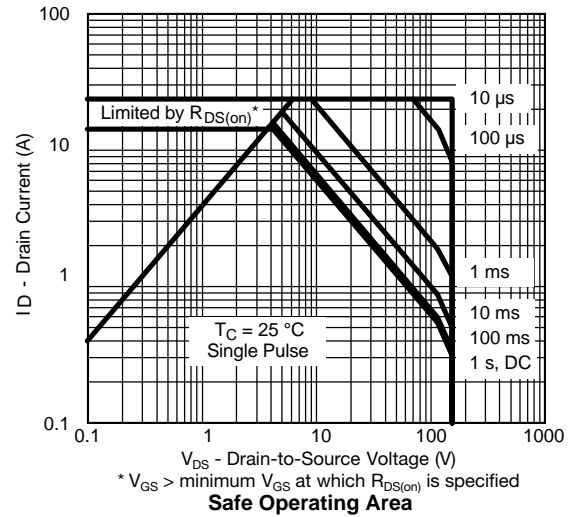


Source-Drain Diode Forward Voltage

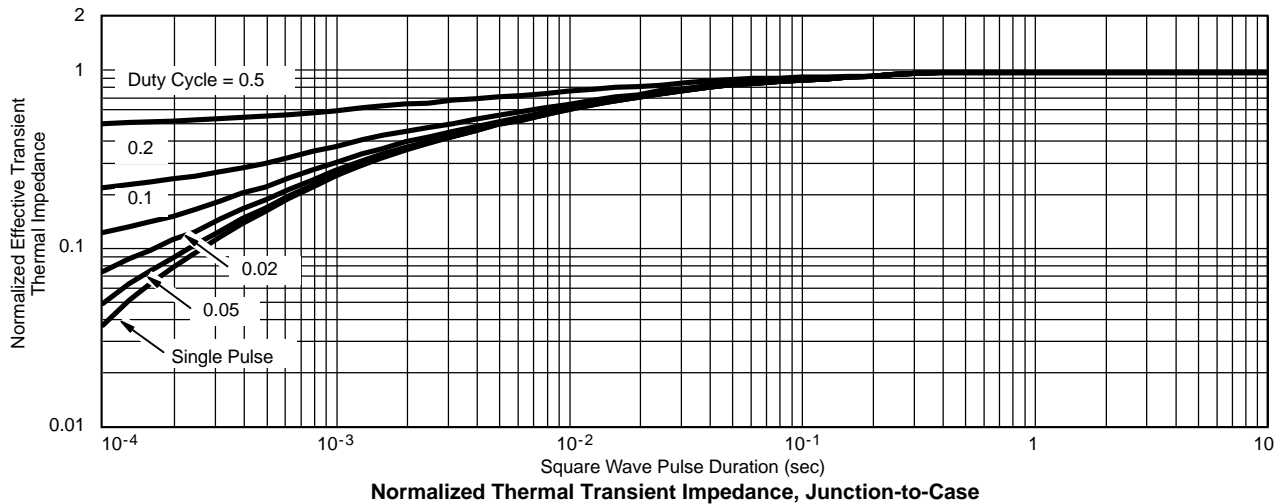
