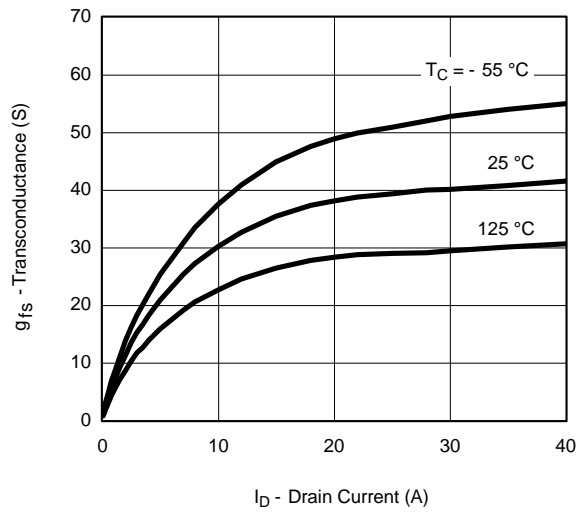

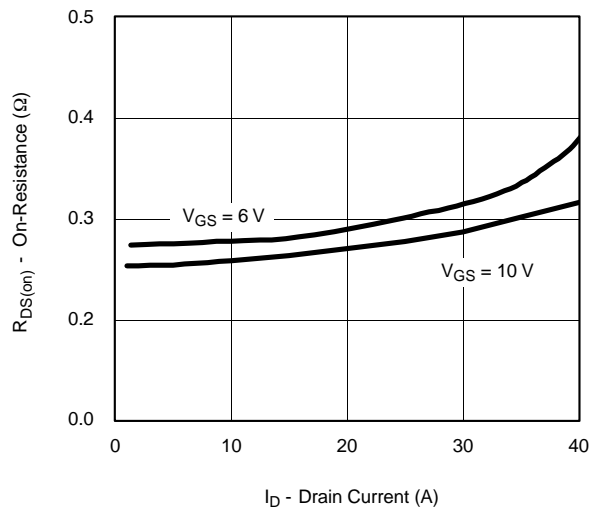

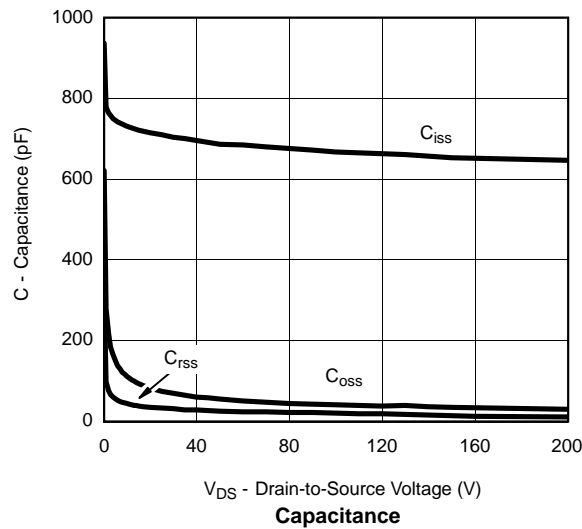

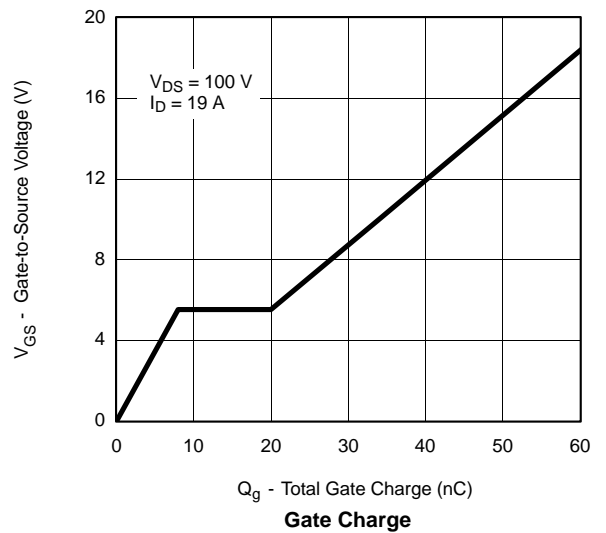

vs. Case Temperature



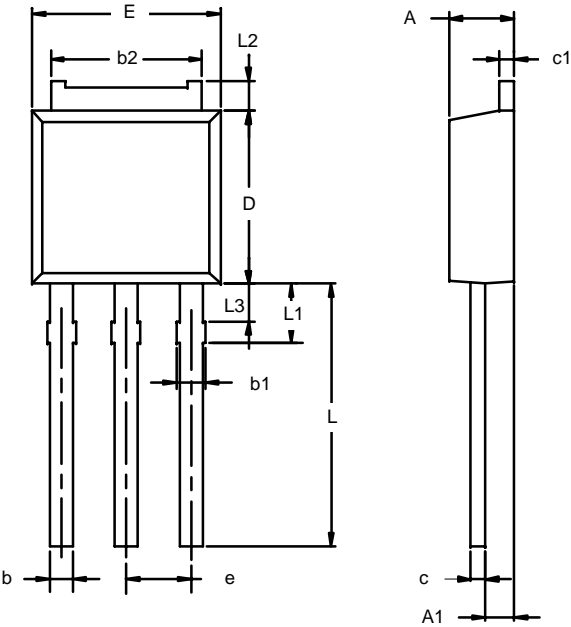
