





5 V<sub>GS</sub> - Gate-to-Source Voltage (V) On-Resistance vs. Gate-to-Source Voltage





Single Pulse Power (Junction-to-Ambient)





#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Ambient
