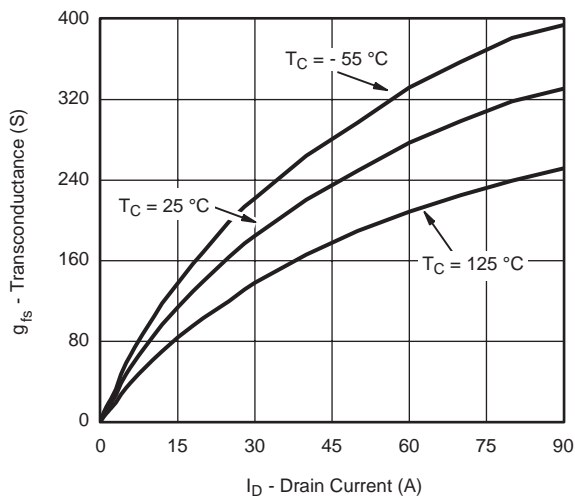

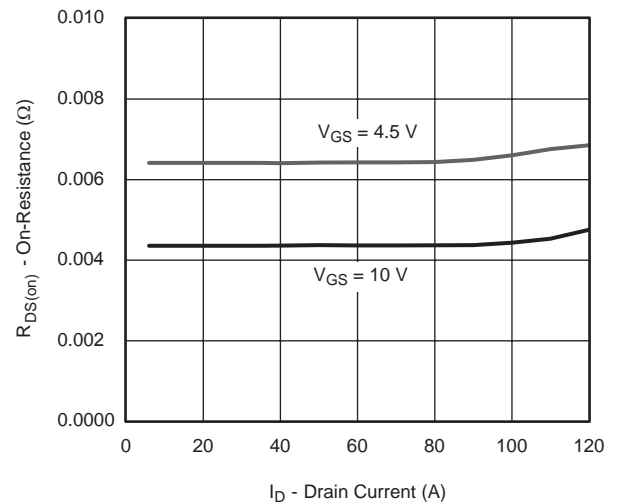

**Transfer Characteristics**



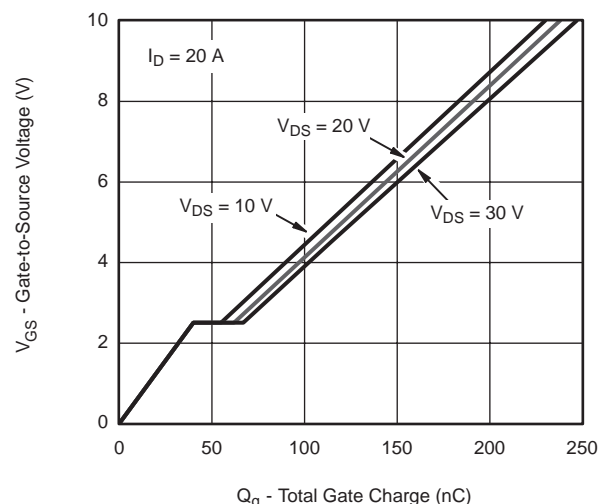
**Transconductance**

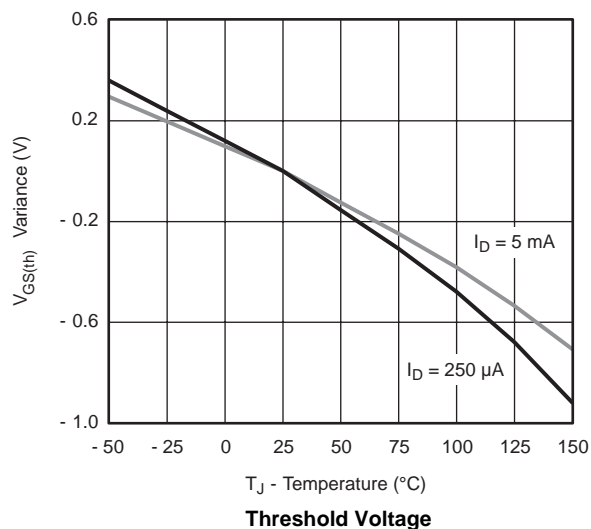
**On-Resistance vs. Junction Temperature**

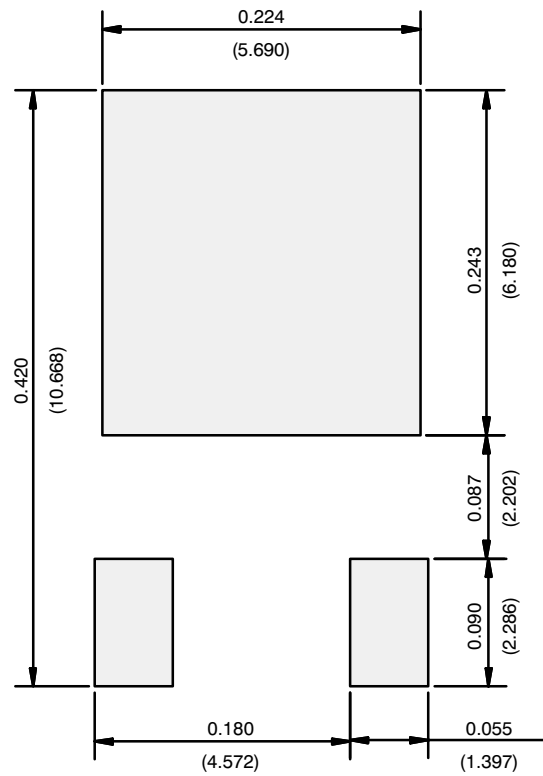
