





Q_g - Total Gate Charge (nC)

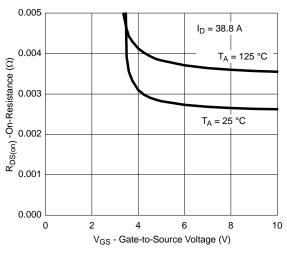



Threshold Voltage




Safe Operating Area, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Case




