



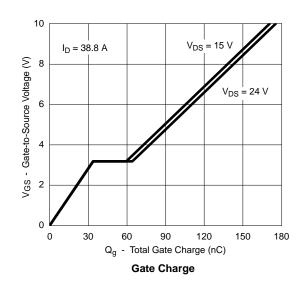




Transfer Characteristics



R_{DS(on)} vs. Drain Current








On-Resistance vs. Junction Temperature



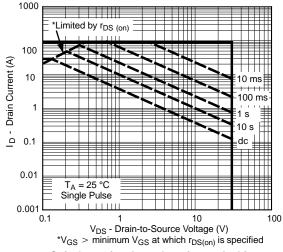
 V_{GS} - Gate-to-Source Voltage (V) $R_{DS(on)}$ vs. V_{GS} vs. Temperature



Forward Diode Voltage vs. Temperature




Threshold Voltage

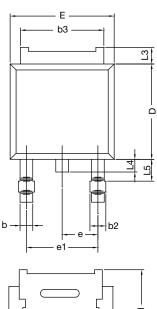




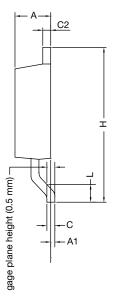
Normalized Thermal Transient Impedance, Junction-to-Case


