



Q<sub>g</sub> - Total Gate Charge (nC)



Forward Diode Voltage vs. Temperature




Threshold Voltage




Normalized Thermal Transient Impedance, Junction-to-Case



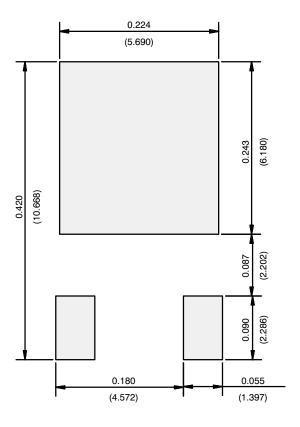
