




Safe Operating Area



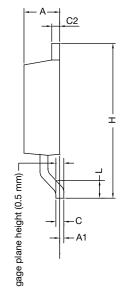

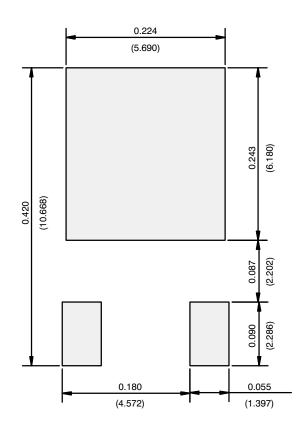
