



#### TYPICAL CHARACTERISTICS 25 °C unless noted




On-Resistance vs. Junction Temperature


**Drain Current vs. Case Temperature** 





#### Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Case


