


Source-Drain Diode Forward Voltage




**Threshold Voltage** 




 $V_{DS}$  - Drain-to-Source Voltage (V)  $\label{eq:capacitance}$ 



**Drain Source Breakdown vs. Junction Temperature** 




On-Resistance vs. Junction Temperature








Single Pulse Avalanche Current Capability vs. Time


Normalized Thermal Transient Impedance, Junction-to-Case




