

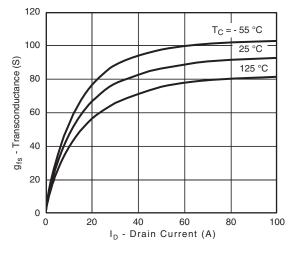
Source Drain Diode Forward Voltage






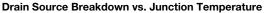


On-Resistance vs. Gate-to Source Voltage










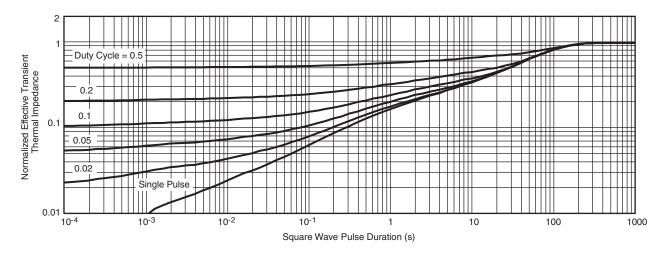


Safe Operating Area



Normalized Thermal Transient Impedance, Junction-to-Case





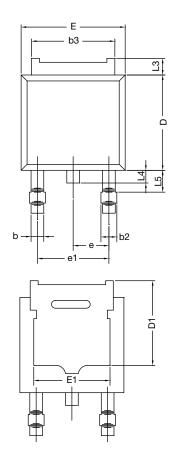
Normalized Thermal Transient Impedance, Junction-to-Ambient




