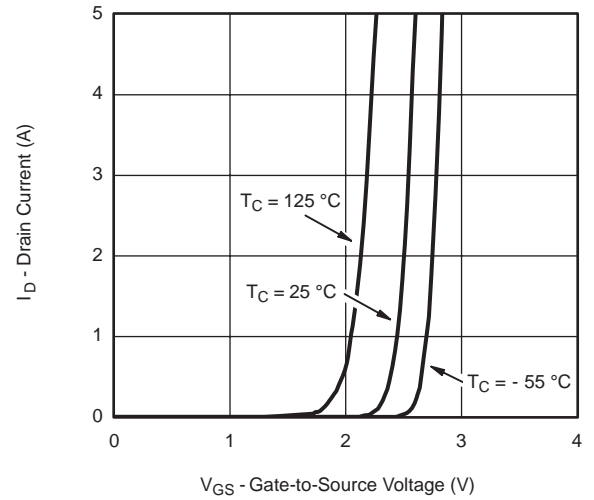

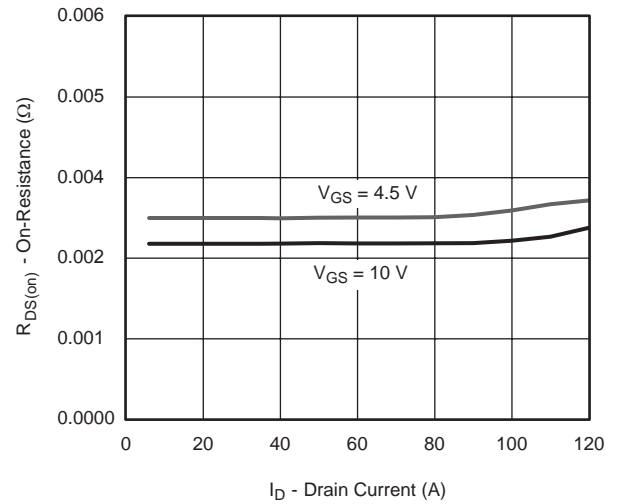

Transfer Characteristics



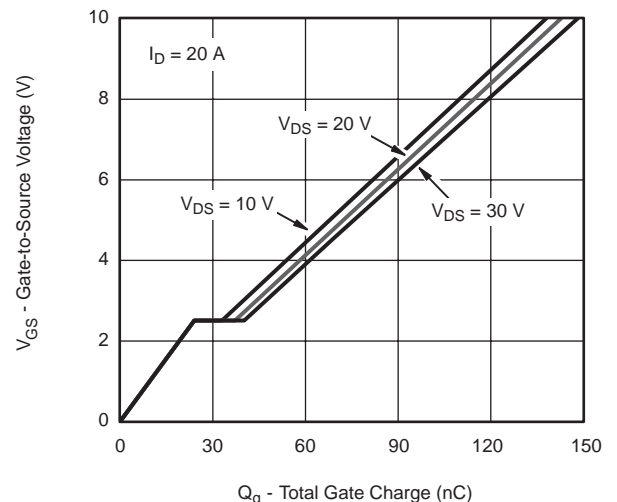
Transconductance

Capacitance

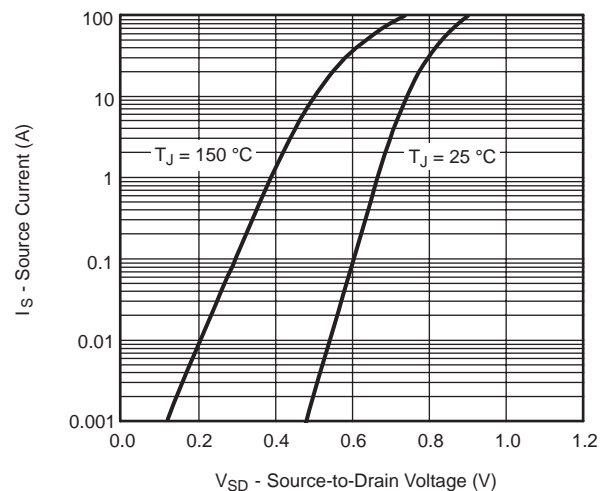

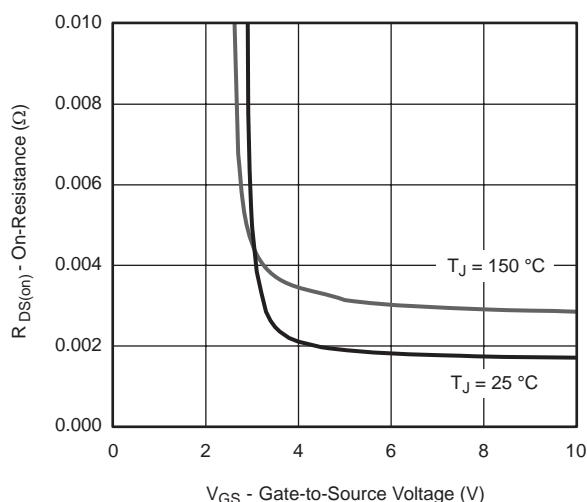

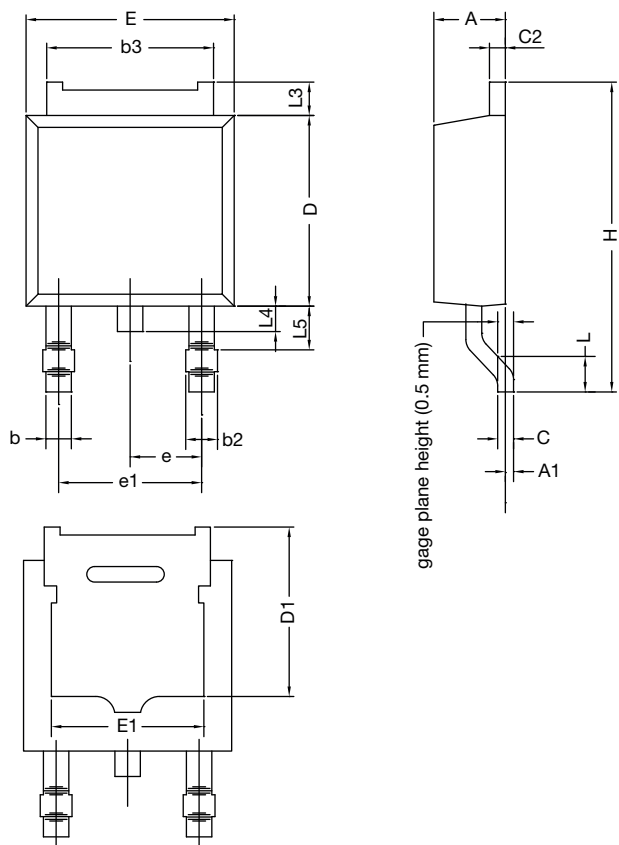
