








**On-Resistance vs. Drain Current** 









**On-Resistance vs. Junction Temperature** 




Source Drain Diode Forward Voltage



Drain Source Breakdown vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage






Safe Operating Area




