








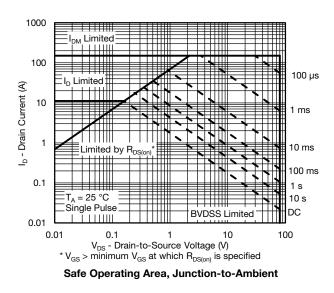




On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient





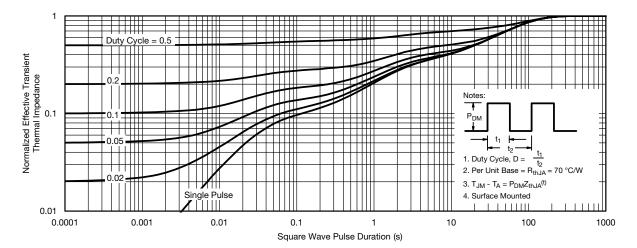

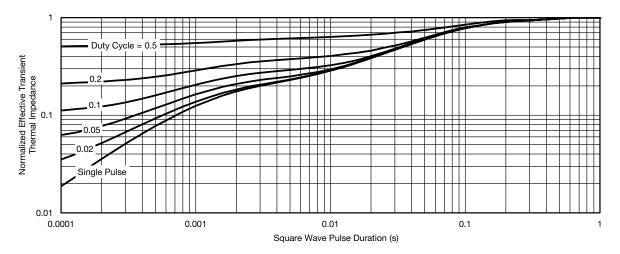

#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)








Normalized Thermal Transient Impedance, Junction-to-Case


