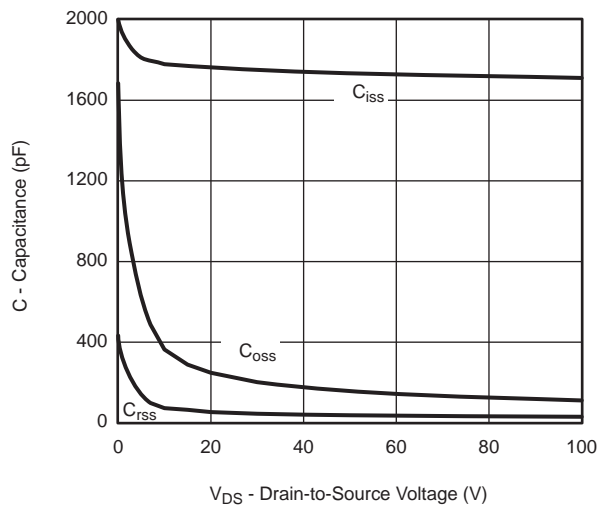

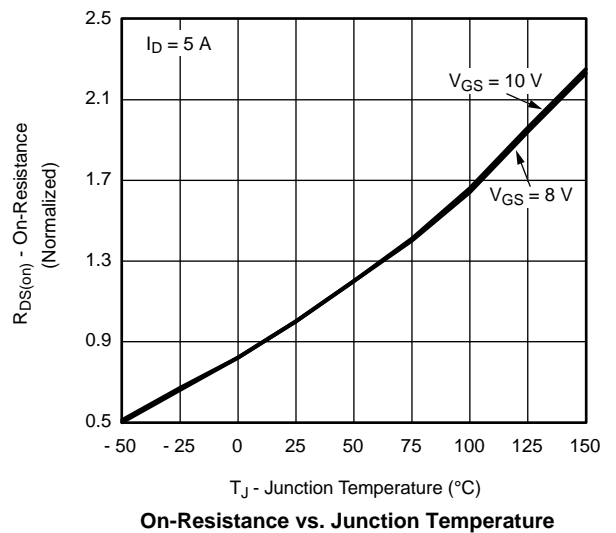
**On-Resistance vs. Drain Current and Gate Voltage**

**On-Resistance vs. Junction Temperature**

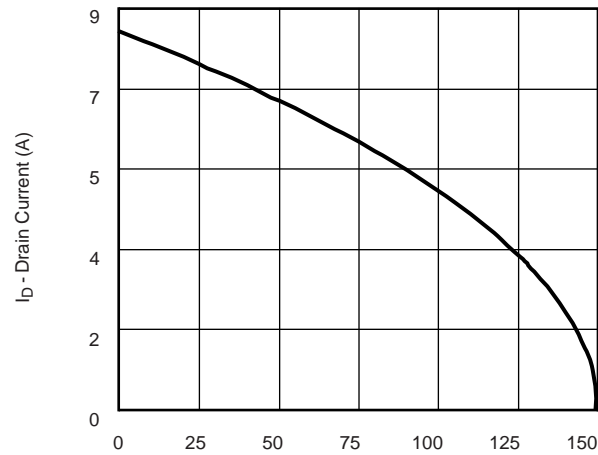

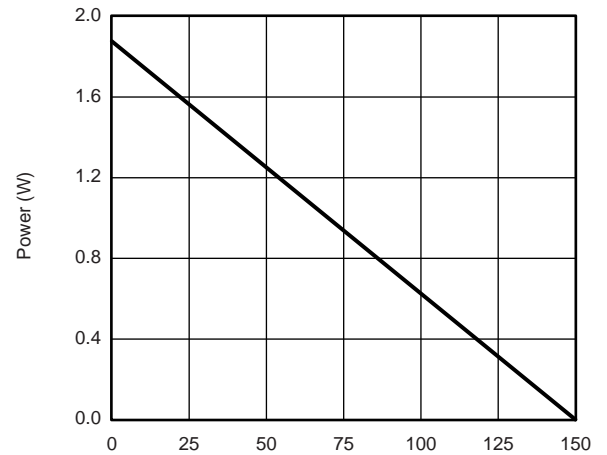

**Power, Junction-to-Case**



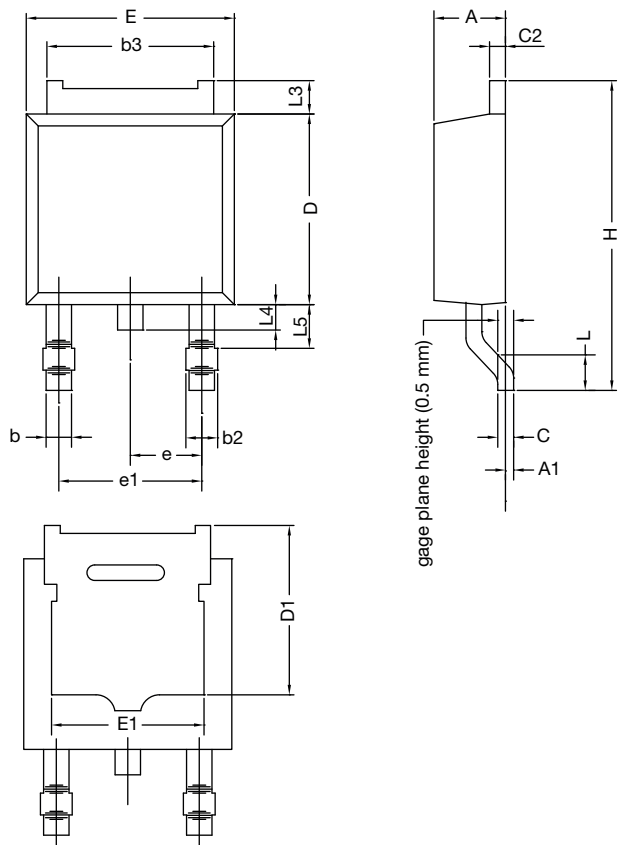

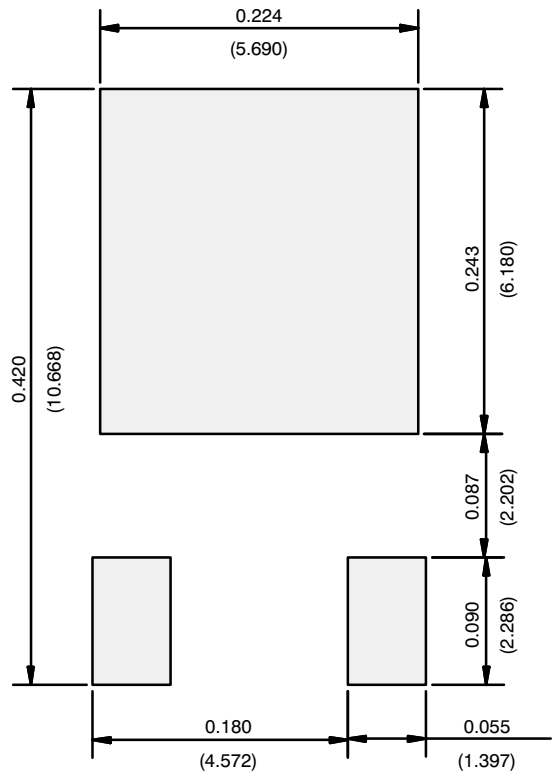
