







 $V_{GS}$  - Gate-to-Source Voltage (V)


R<sub>DS(on)</sub> vs. V<sub>GS</sub> vs. Temperature





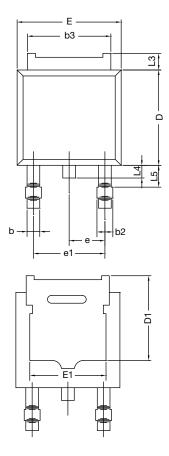
