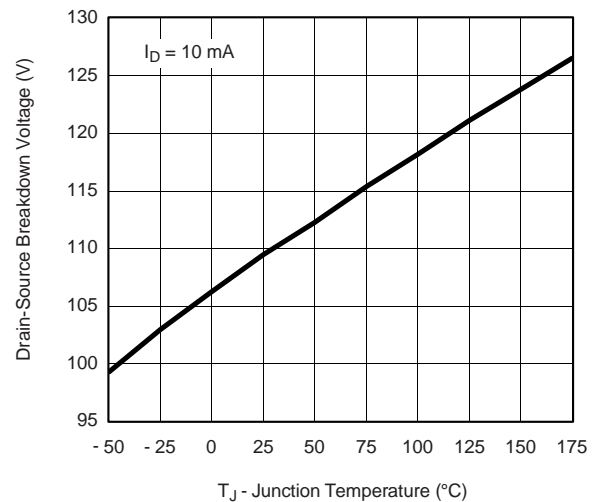

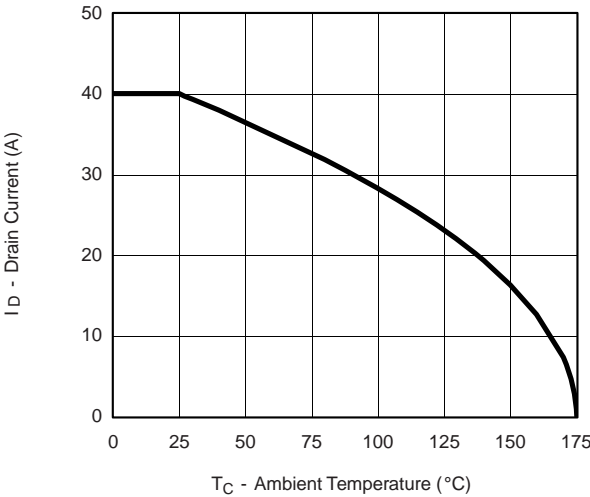

On-Resistance vs. Junction Temperature

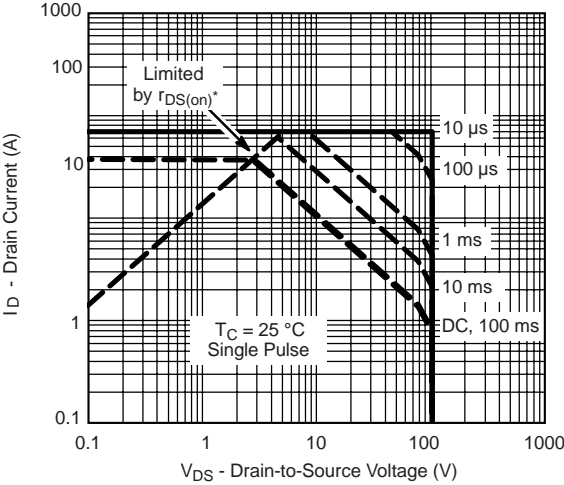

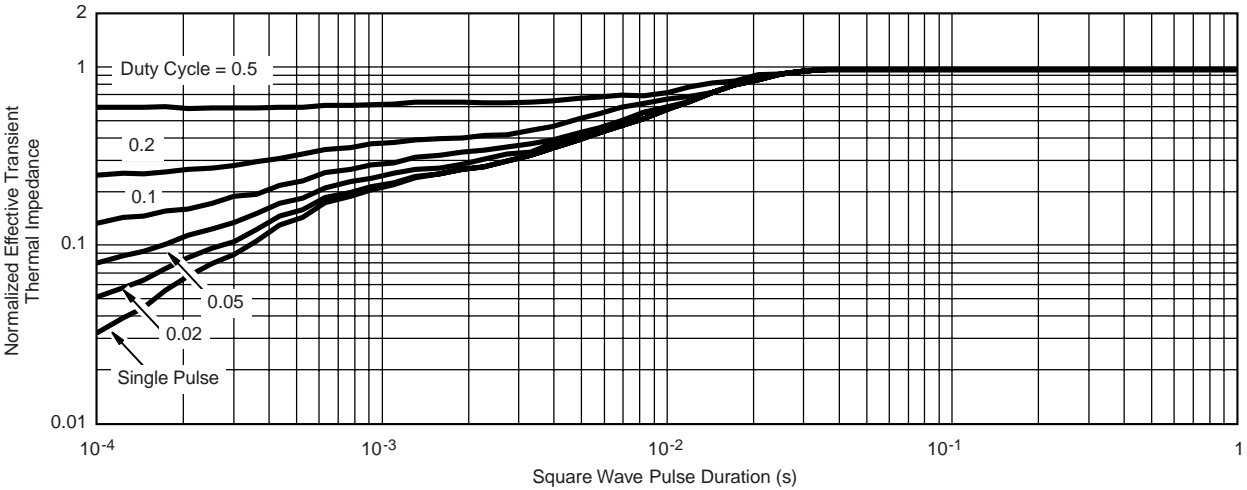


Maximum Avalanche and Drain Current vs. Case Temperature
