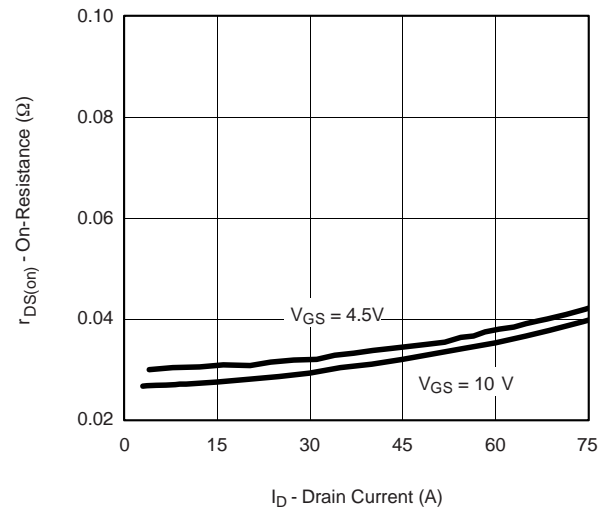

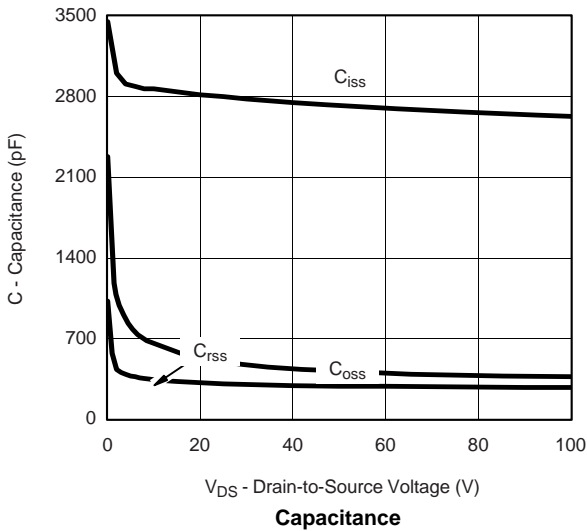

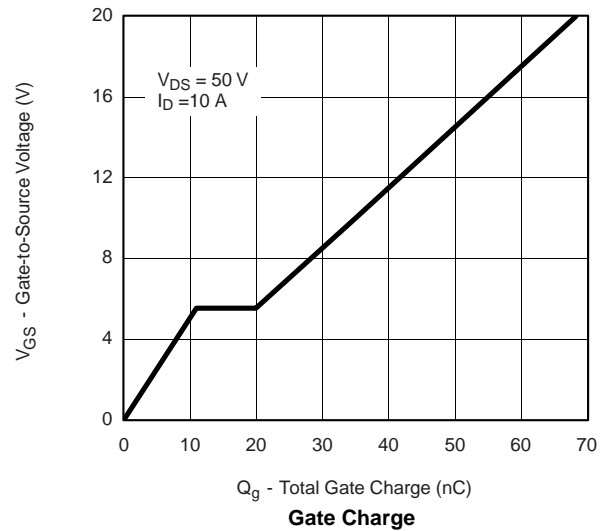

**Source-Drain Diode Forward Voltage**

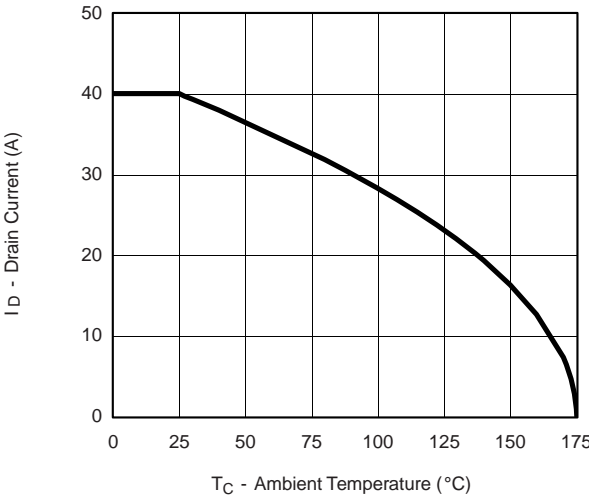


**Avalanche Current vs. Time**
