








TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




vs. Junction Temperature

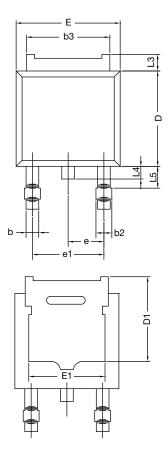
THERMAL RATINGS

TO-252AA CASE OUTLINE






