






TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)

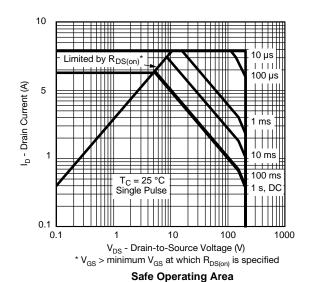




Normalized Effective Transient Thermal Impedance


