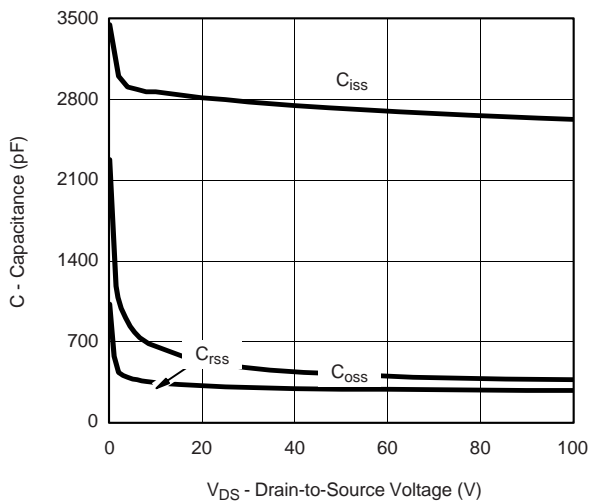

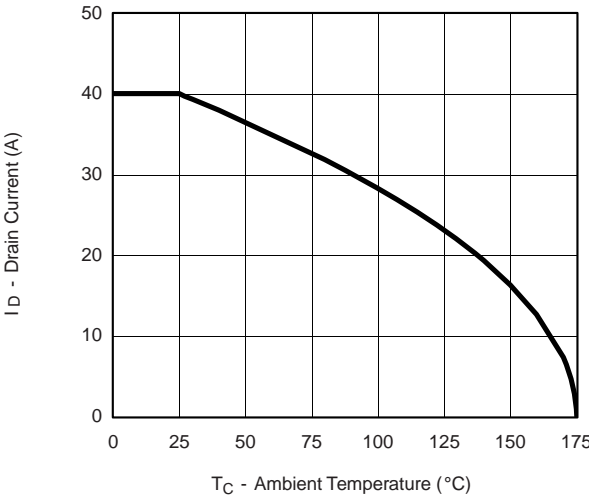


**Avalanche Current vs. Time**



**Drain-Source Breakdown Voltage vs. Junction Temperature**

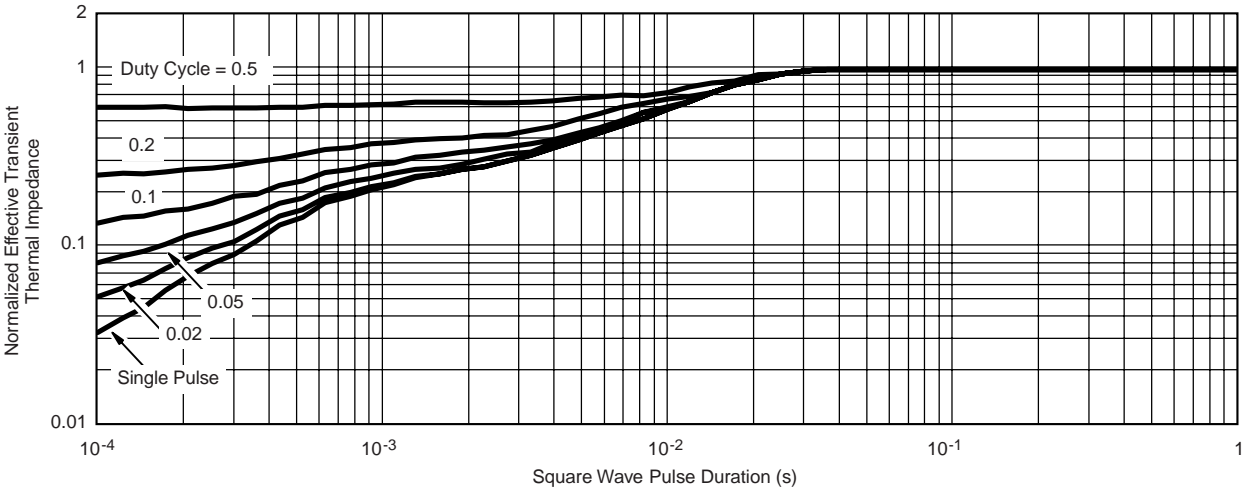
