



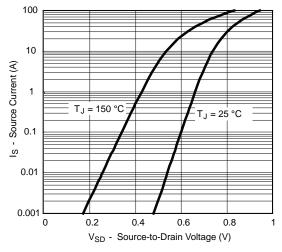


On-Resistance vs. Junction Temperature




 V_{GS} - Gate-to-Source Voltage (V) $R_{DS(on)} \ vs. \ V_{GS} \ vs. \ Temperature$



Forward Diode Voltage vs. Temperature



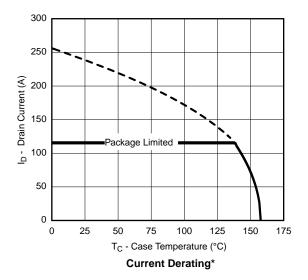
Threshold Voltage




Safe Operating Area, Junction-to-Ambient






Normalized Thermal Transient Impedance, Junction-to-Case


