TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)








R_{DS(on)} vs. V_{GS} vs. Temperature




Forward Diode Voltage vs. Temperature











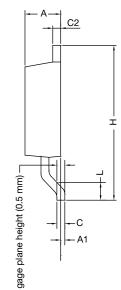

TO-252AA CASE OUTLINE






