







T_C - Case Temperature (°C)

vs. Case Temperature




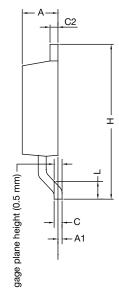


