











T_J - Junction Temperature (°C)




On-Resistance vs. Gate-to Source Voltage








Safe Operating Area





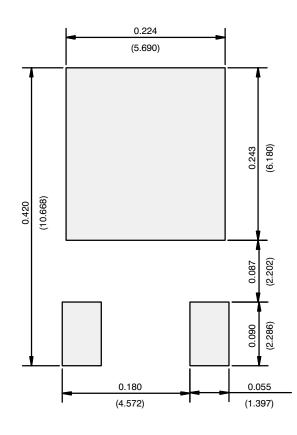
