










Transfer Characteristics




On-Resistance vs. Drain Current




Gate Charge

On-Resistance vs. Junction Temperature




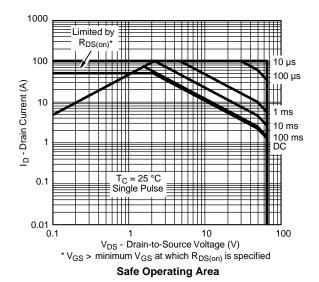



Maximum Drain Current vs. Ambient Temperature




Normalized Thermal Transient Impedance, Junction-to-Case




