












On-Resistance vs. Gate-to Source Voltage













Safe Operating Area



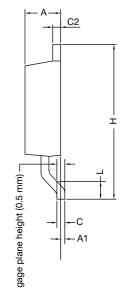


