




Transconductance






Transfer Characteristics



R<sub>DS(on)</sub> vs. Drain Current



Forward Diode Voltage vs. Temperature








Safe Operating Area, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Case


