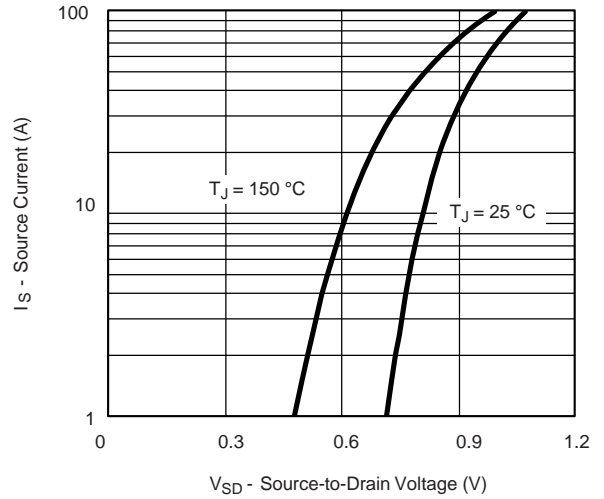

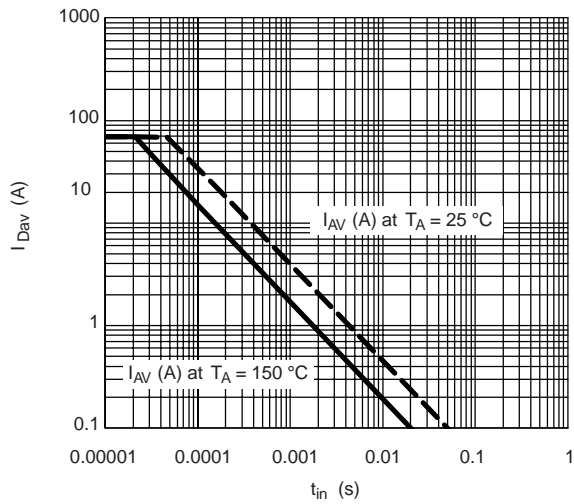

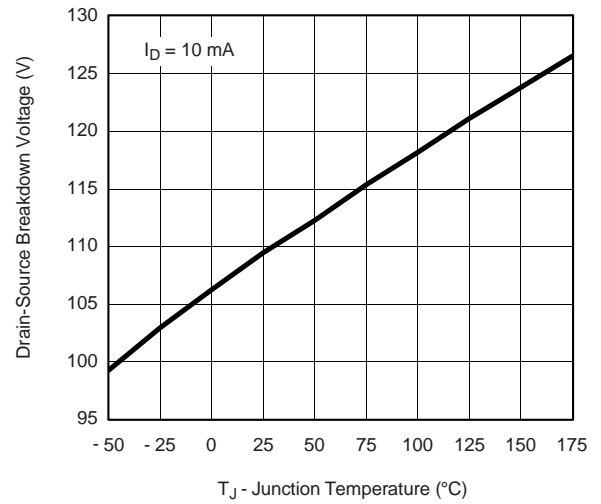
On-Resistance vs. Junction Temperature

Avalanche Current vs. Time

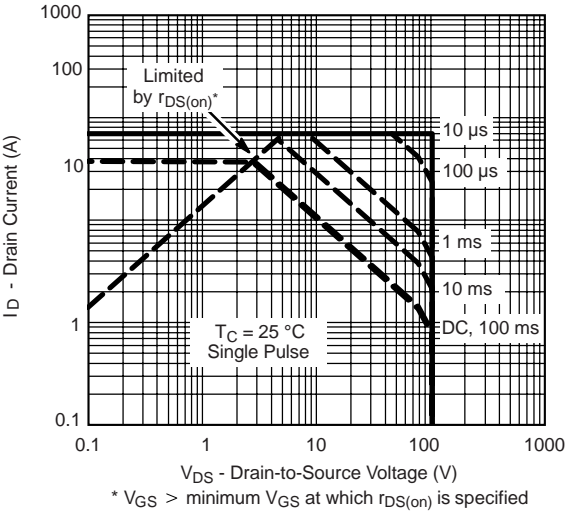


Drain-Source Breakdown Voltage vs. Junction Temperature

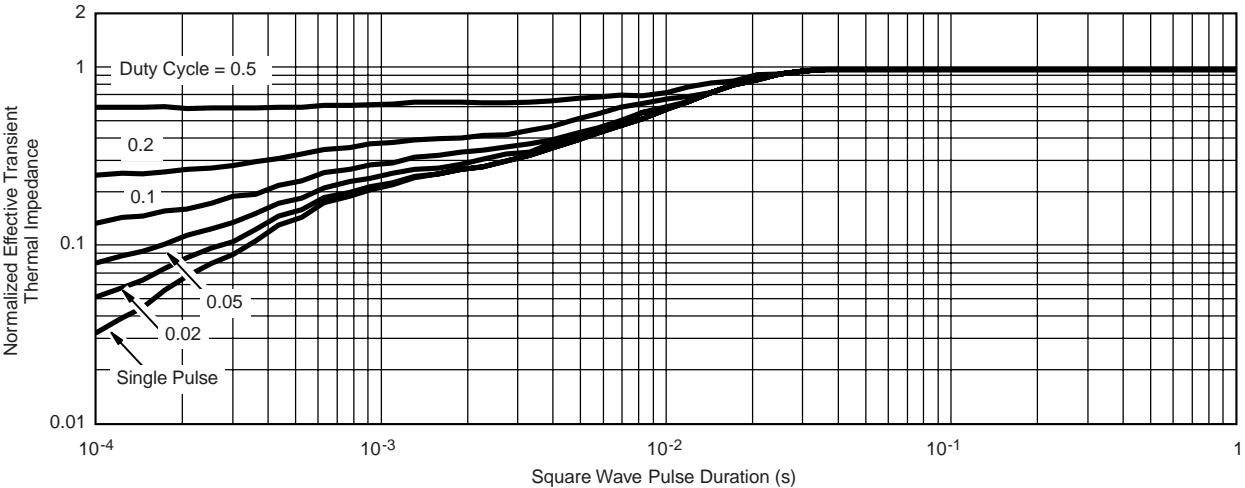
