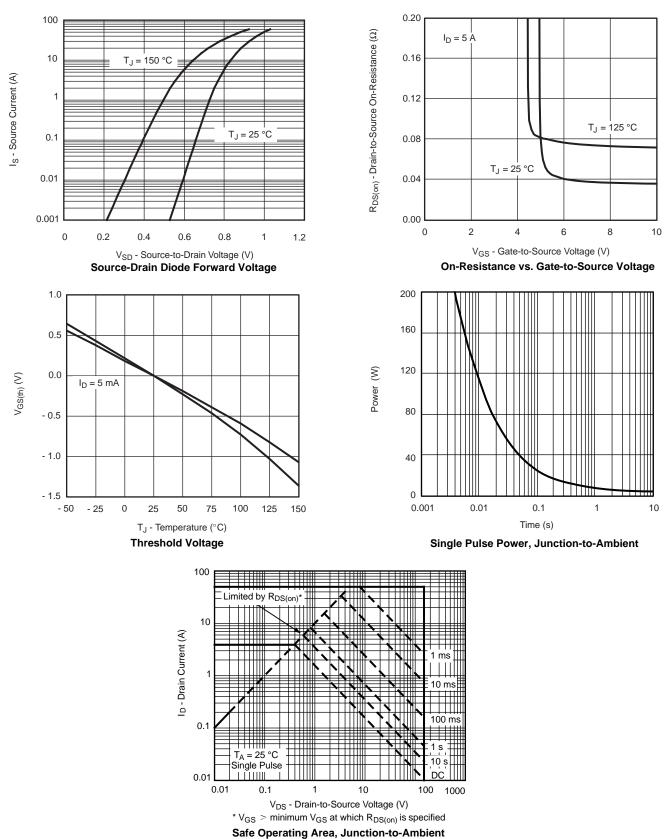


Qg - Total Gate Charge (nC) Gate Charge

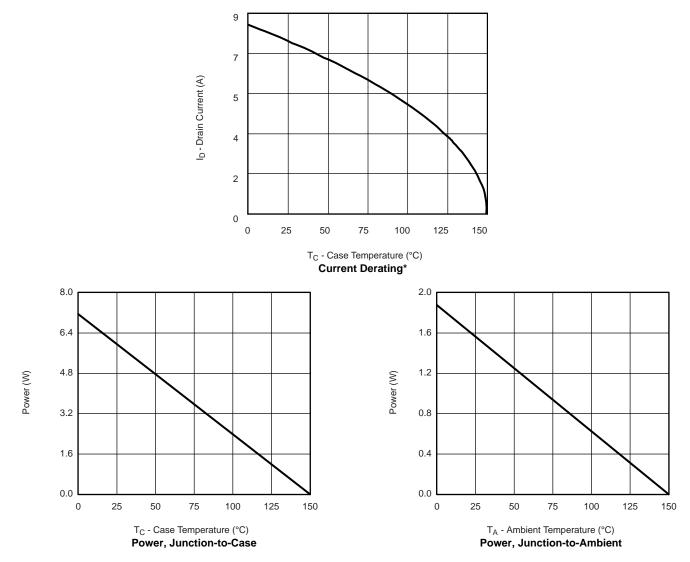






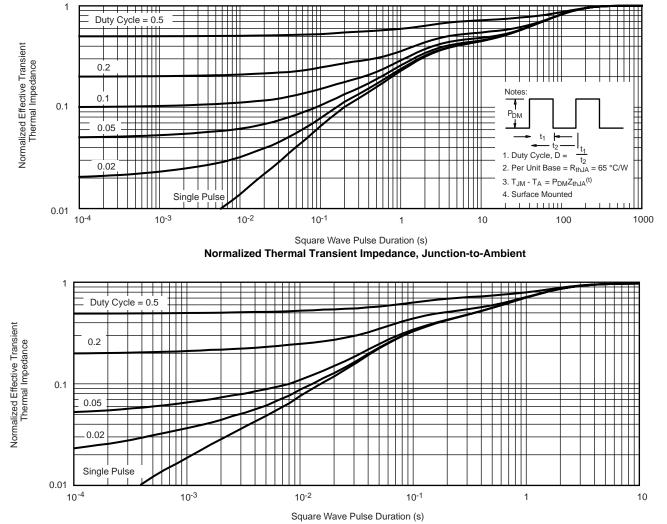

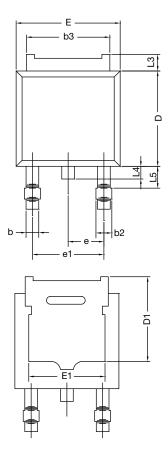




Normalized Thermal Transient Impedance, Junction-to-Foot
