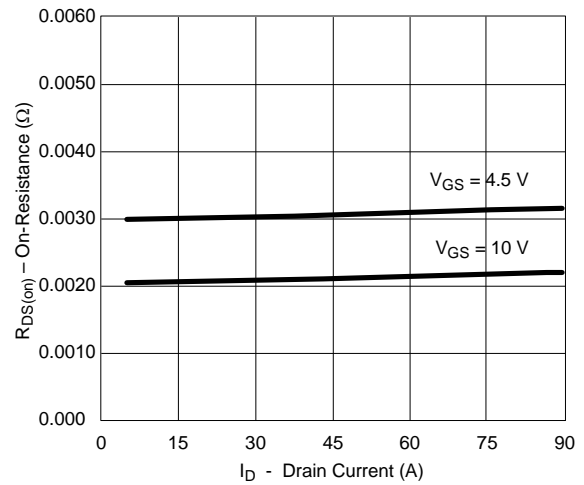

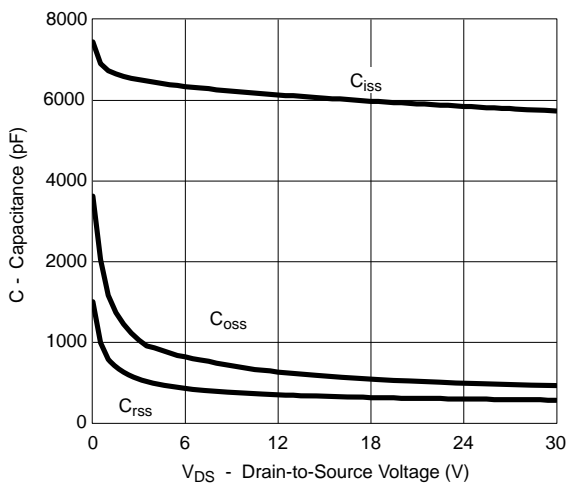

$R_{DS(on)}$  vs. Drain Current

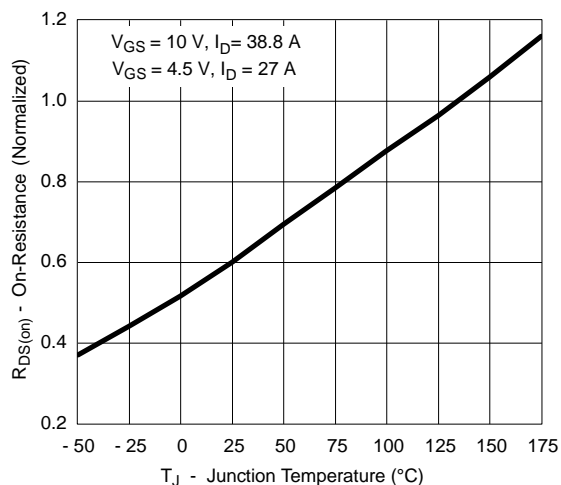

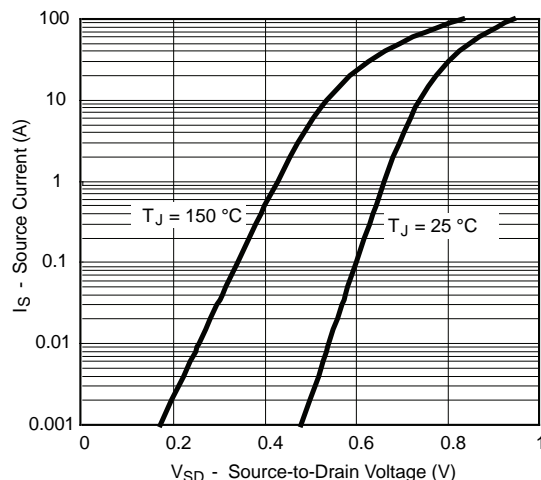

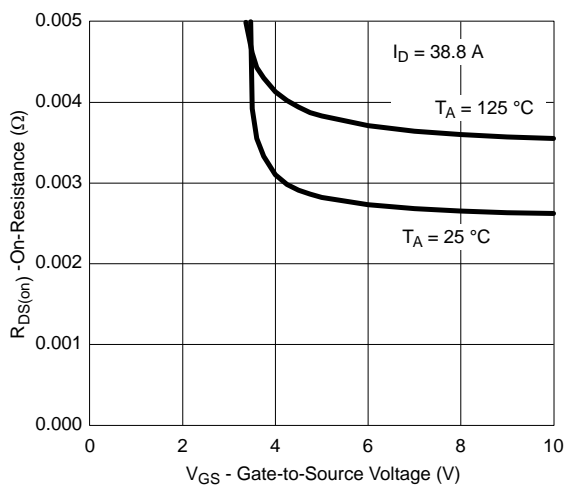

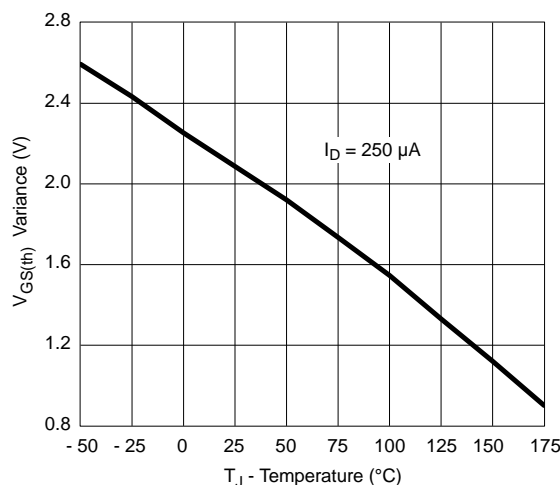
**On-Resistance vs. Junction Temperature**

**$R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature**

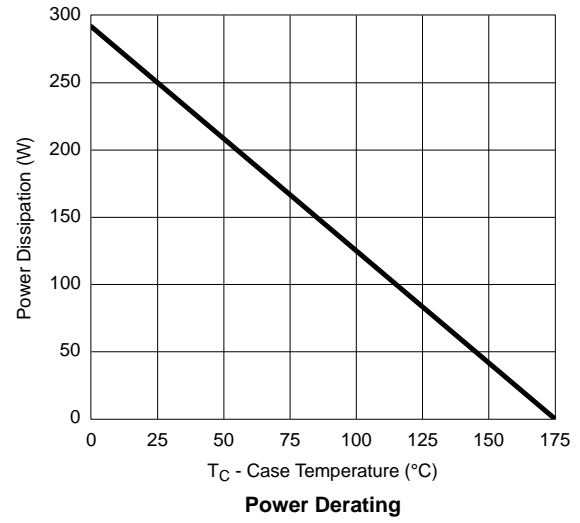
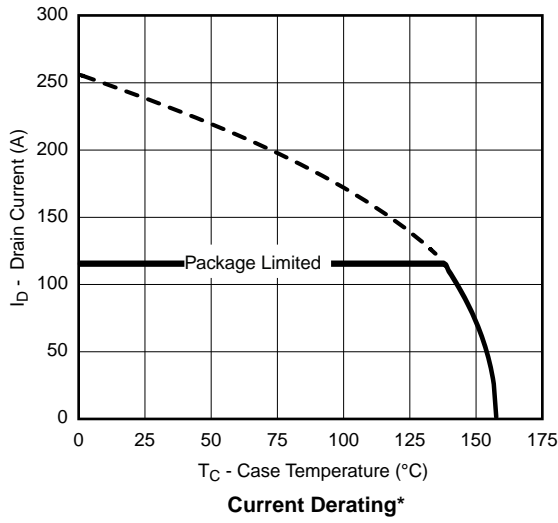

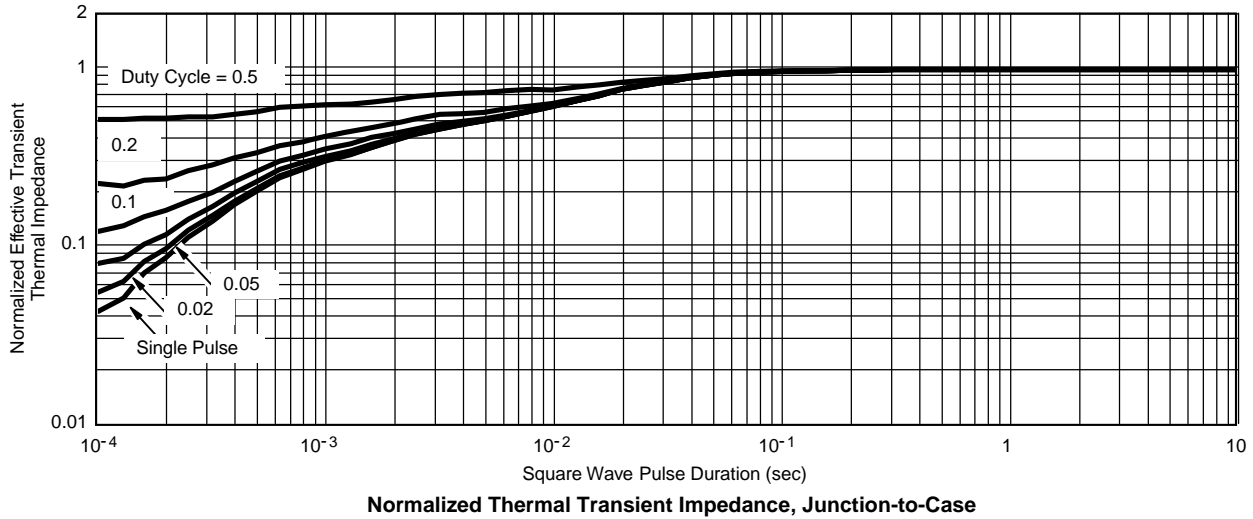
