






V<sub>DS</sub> - Drain-to-Source Voltage (V) Capacitance

Forward Diode Voltage vs. Temperature



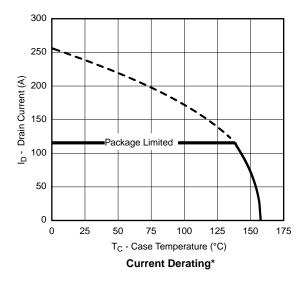




Safe Operating Area, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Case


