



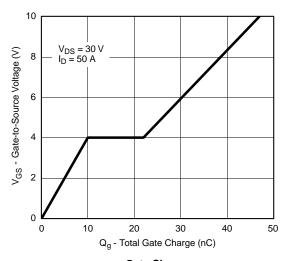

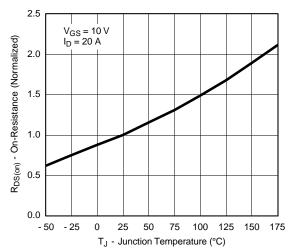
On-Resistance vs. Drain Current





On-Resistance vs. Junction Temperature

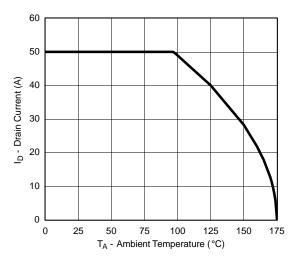


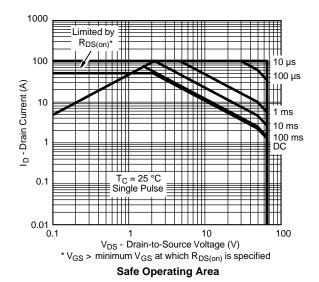



**Maximum Drain Current vs. Ambient Temperature** 




Normalized Thermal Transient Impedance, Junction-to-Case


