


Q_g - Total Gate Charge (nC) Gate Charge

On-Resistance vs. Junction Temperature





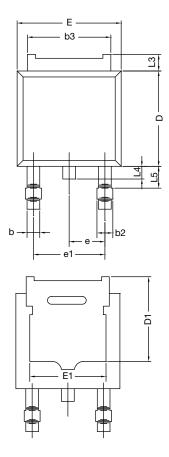




Normalized Thermal Transient Impedance, Junction-to-Foot


