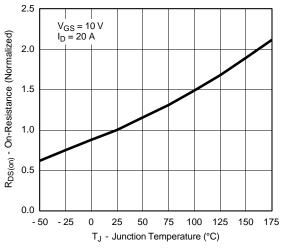
#### TYPICAL CHARACTERISTICS (25 °C unless noted)








#### TYPICAL CHARACTERISTICS (25 °C unless noted)




**On-Resistance vs. Junction Temperature**






Normalized Thermal Transient Impedance, Junction-to-Case
