
### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





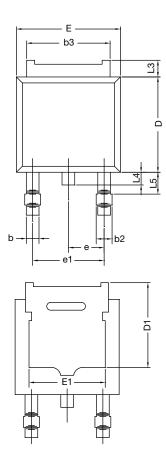




Normalized Thermal Transient Impedance, Junction-to-Case



### **TO-252AA CASE OUTLINE**






