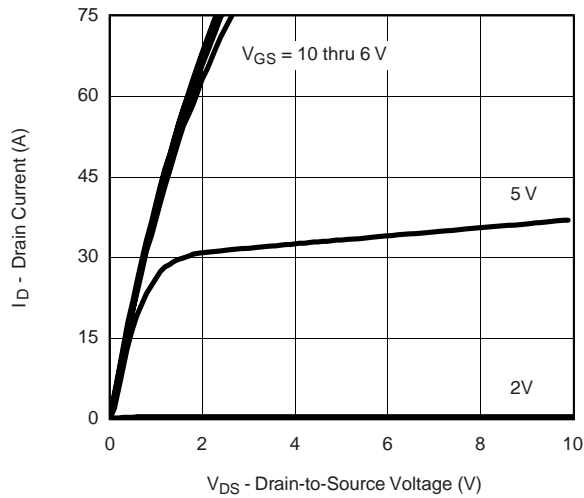

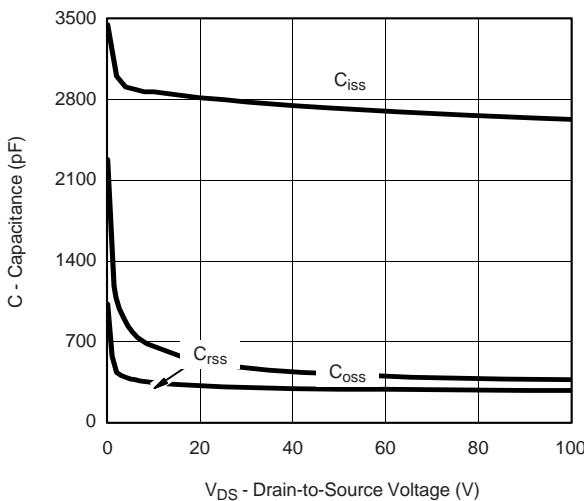

Source-Drain Diode Forward Voltage

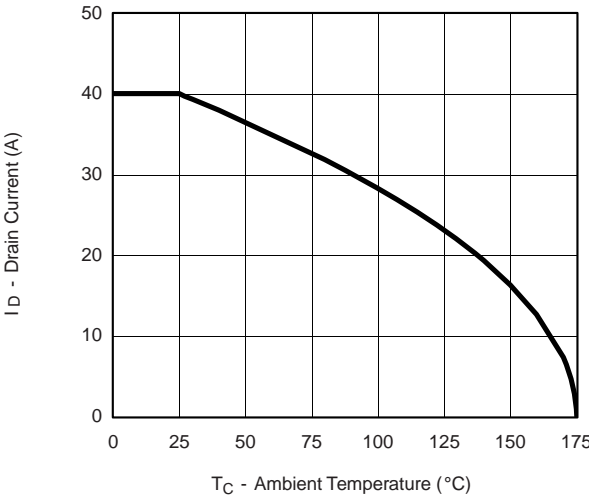


Avalanche Current vs. Time
