













On-Resistance vs. Gate-to Source Voltage







T_J - Junction Temperature (°C) Drain Source Breakdown vs. Junction Temperature



Normalized Thermal Transient Impedance, Junction-to-Case






Normalized Thermal Transient Impedance, Junction-to-Ambient




