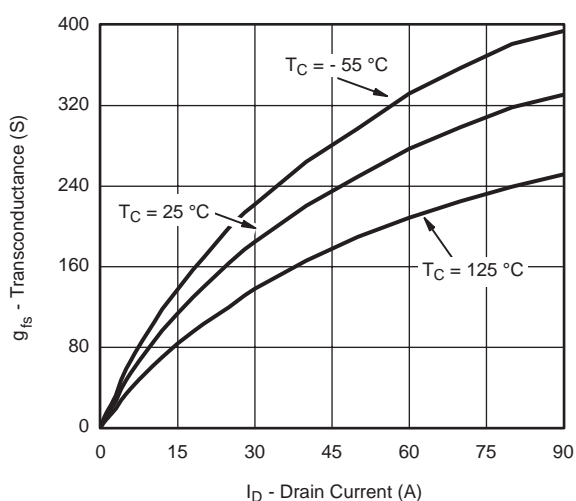

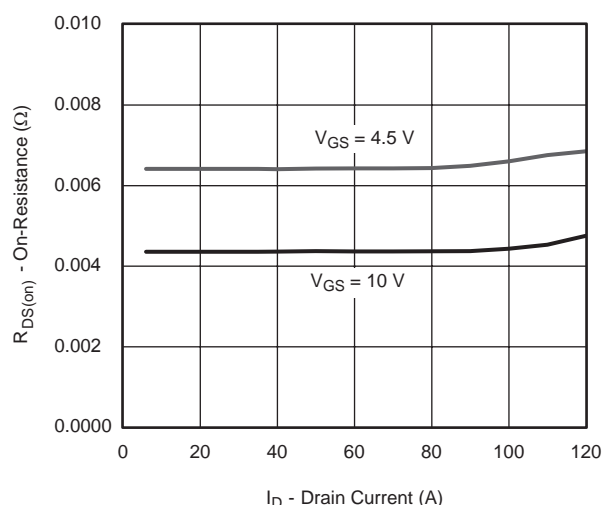

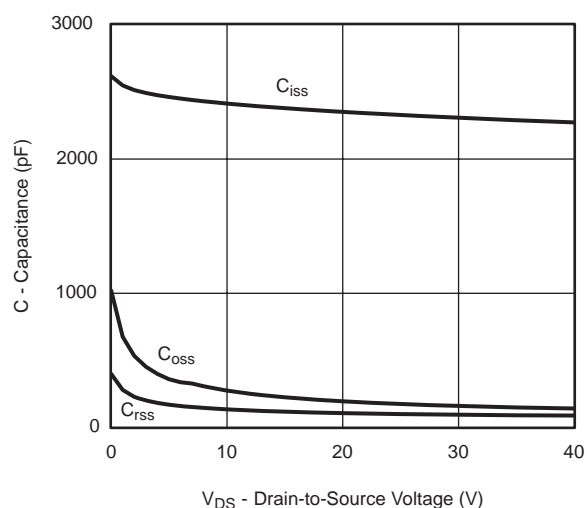

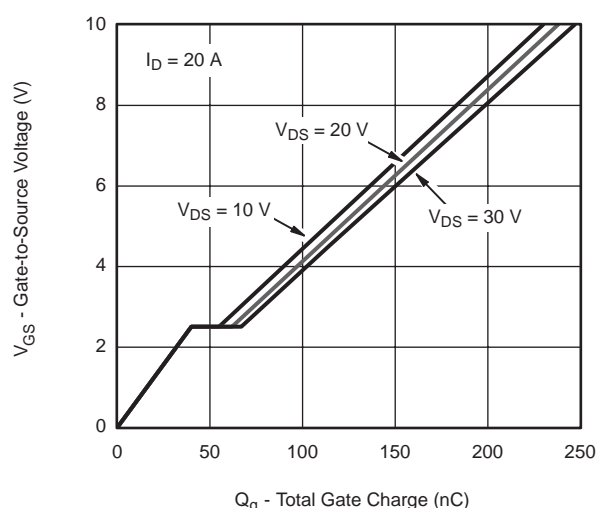
Transconductance

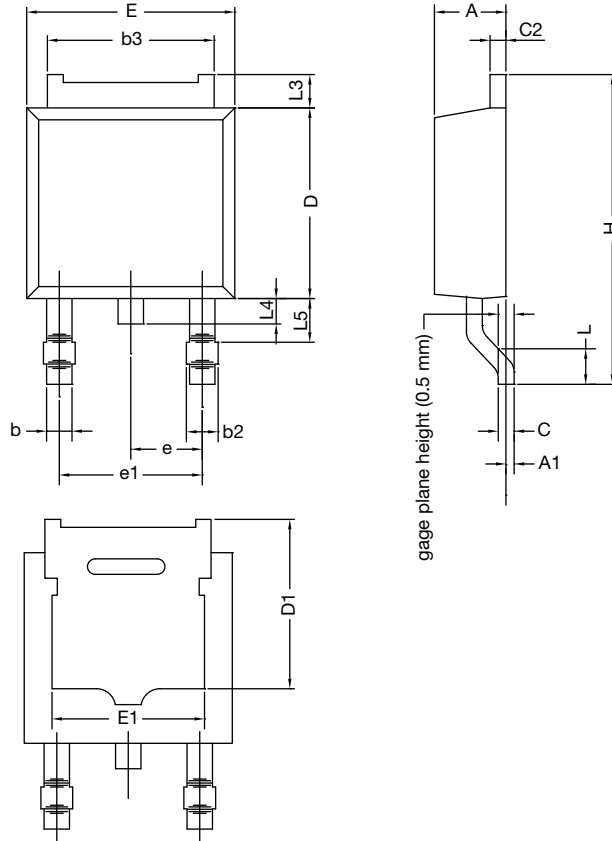
