







#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




#### On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage

Threshold Voltage













Normalized Thermal Transient Impedance, Junction-to-Case


