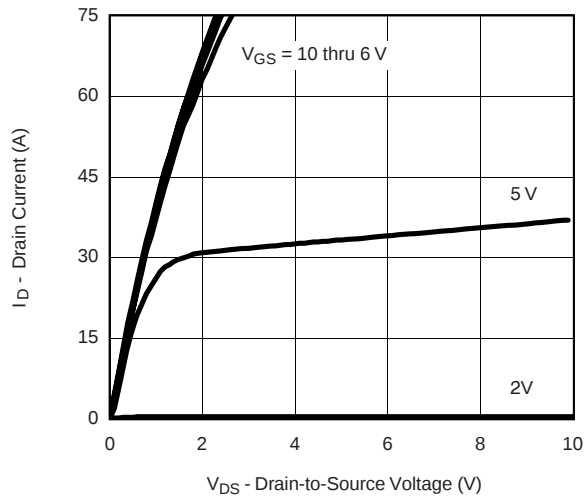

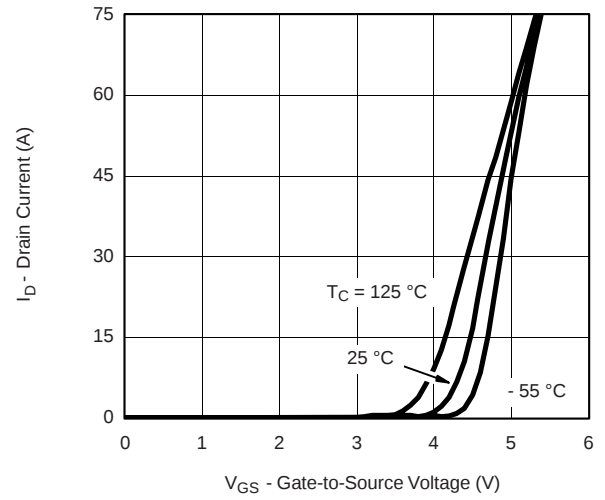

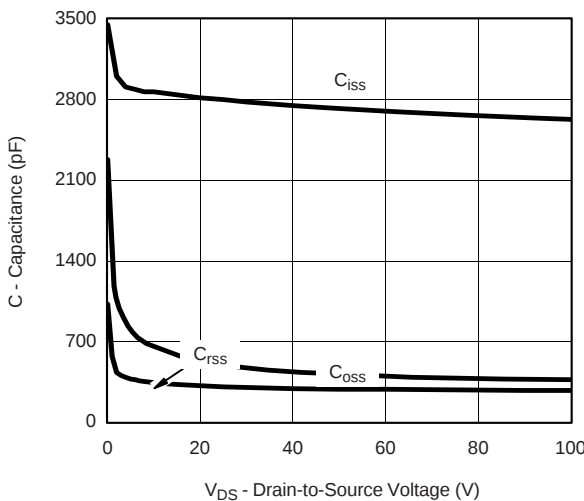

On-Resistance vs. Drain Current

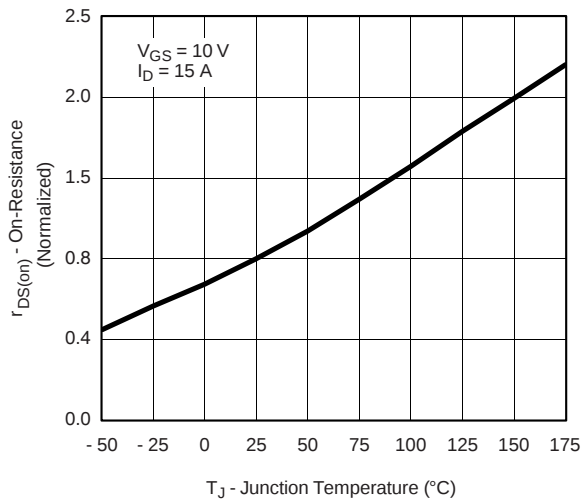

Source-Drain Diode Forward Voltage

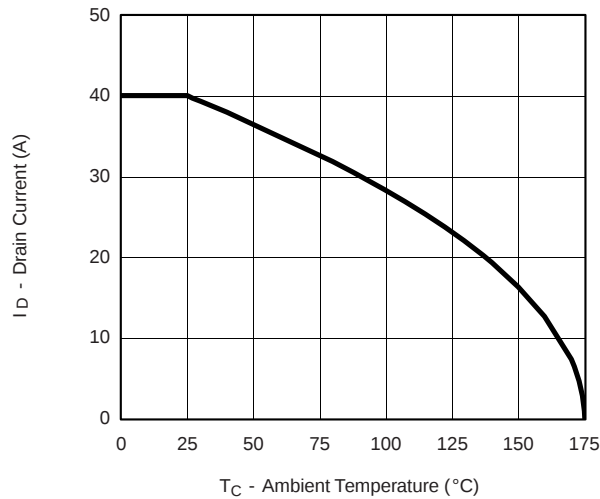


Avalanche Current vs. Time

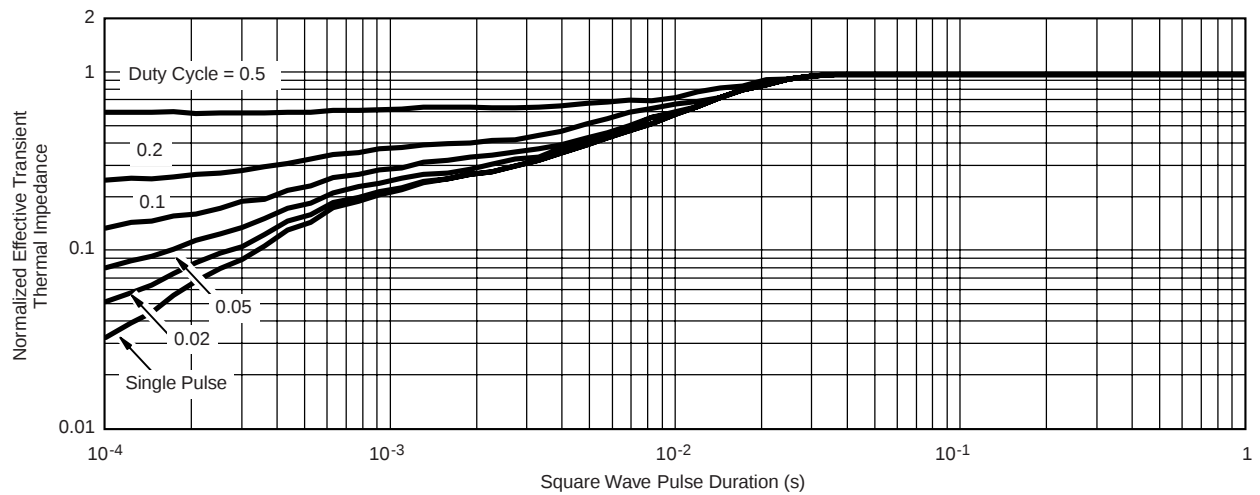


Maximum Avalanche and Drain Current vs. Case Temperature
