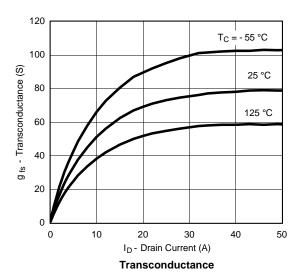


### TYPICAL CHARACTERISTICS (25 °C unless noted)







**Transfer Characteristics** 



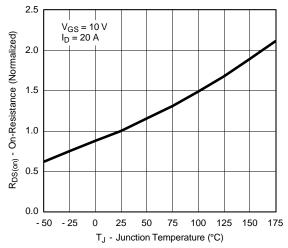
**On-Resistance vs. Drain Current** 





On-Resistance vs. Junction Temperature





Source-Drain Diode Forward Voltage

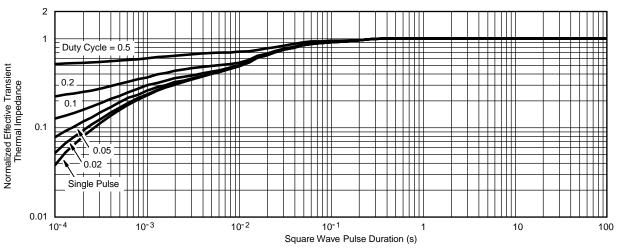
