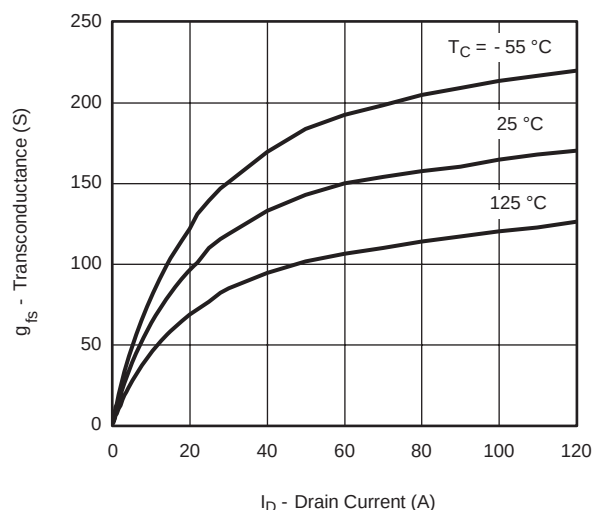

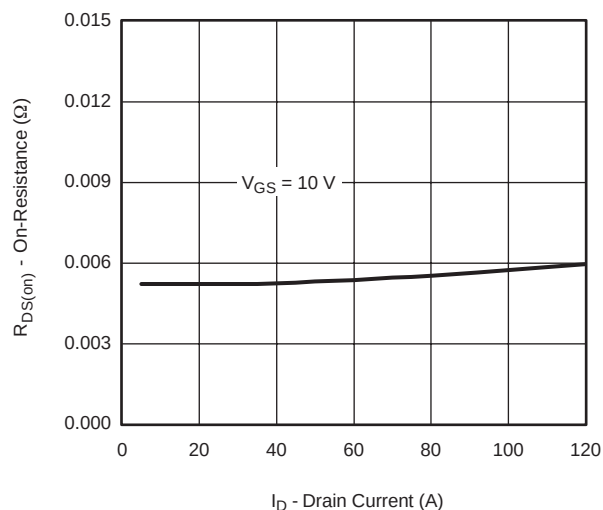

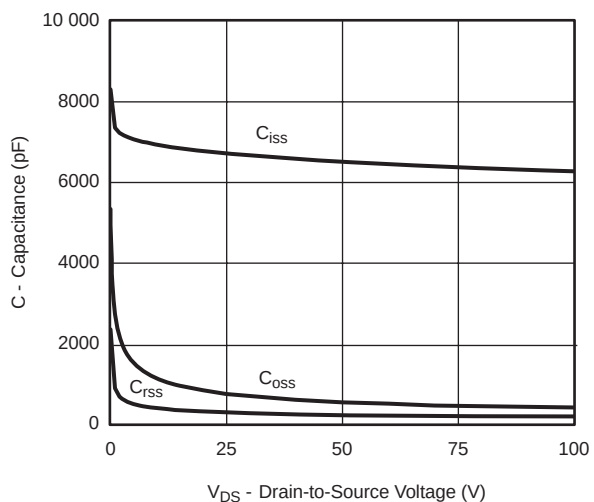

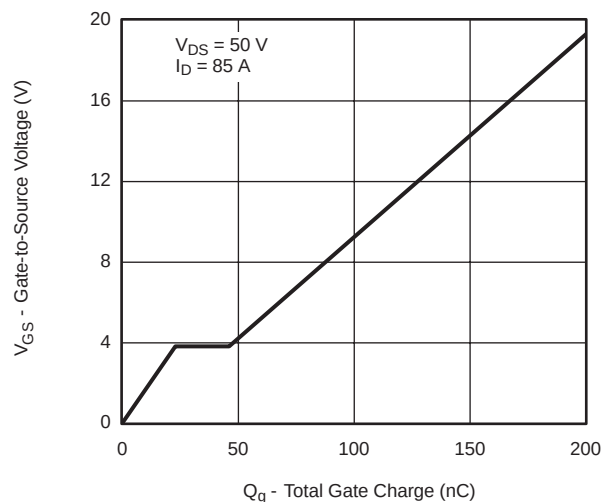
Transconductance



On-Resistance vs. Drain Current

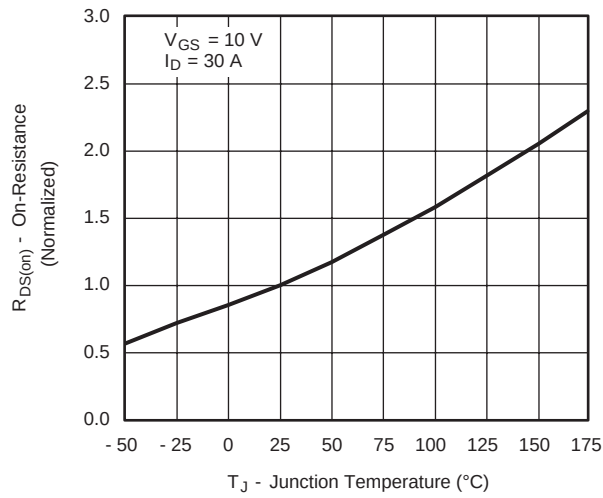


Capacitance

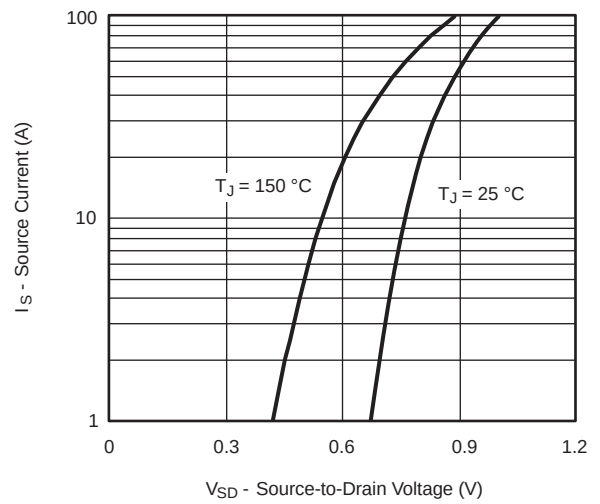


Gate Charge

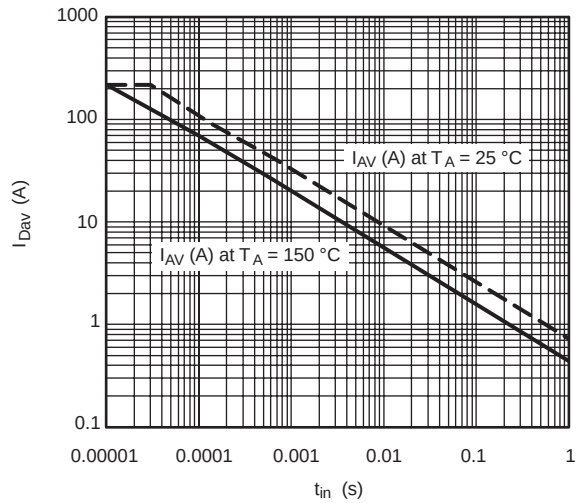

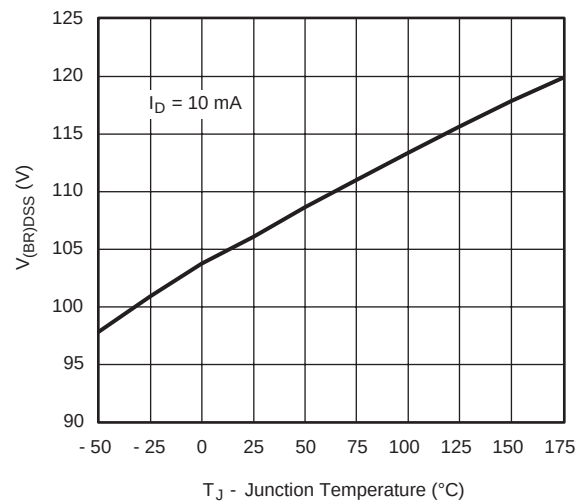
On-Resistance vs. Junction Temperature



Source-Drain Diode Forward Voltage

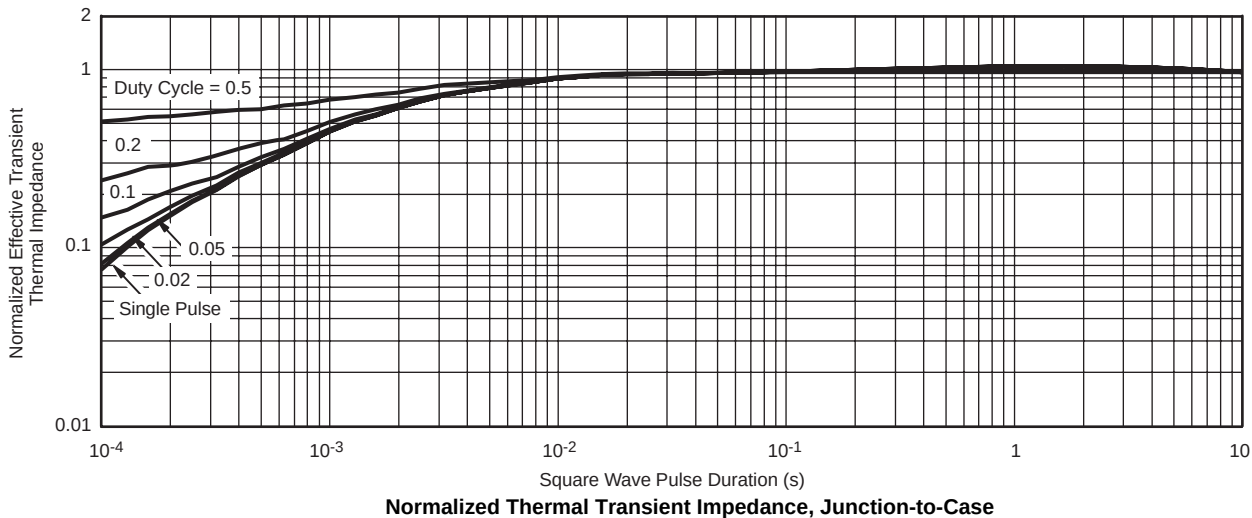
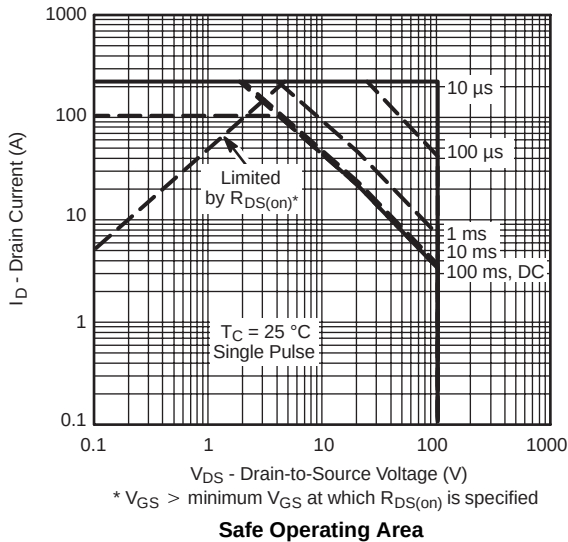
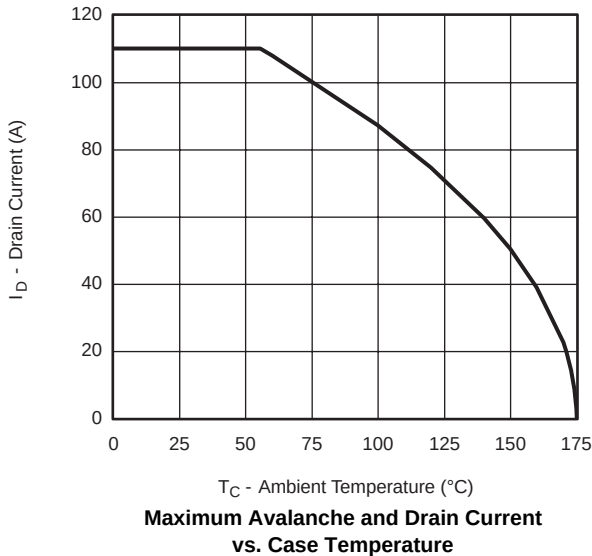


Avalanche Current vs. Time

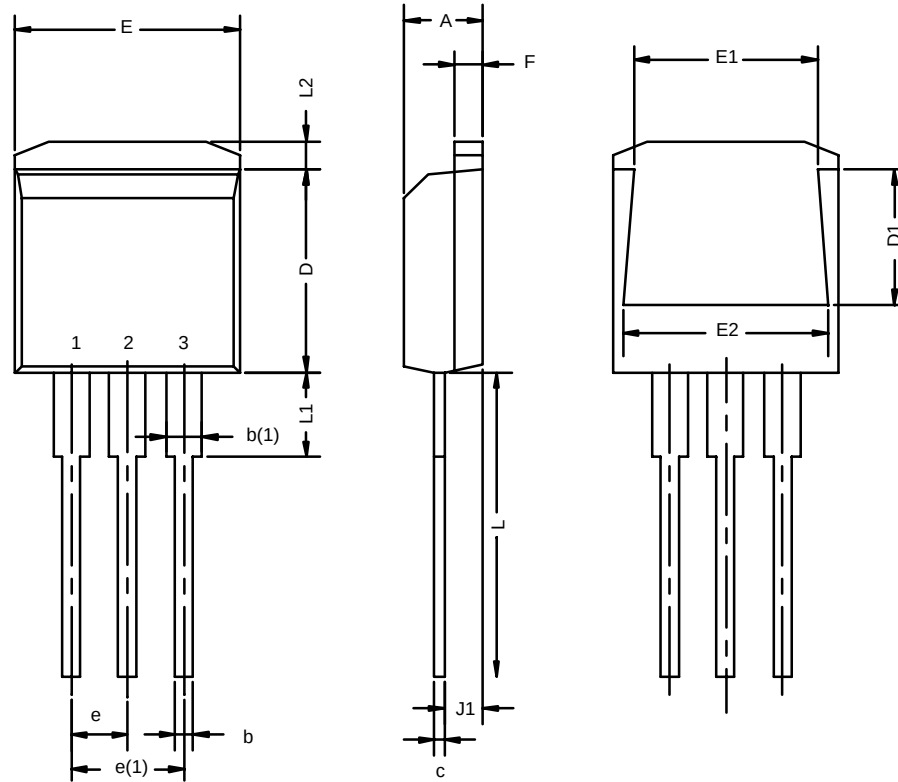


Drain Source Breakdown vs. Junction Temperature
