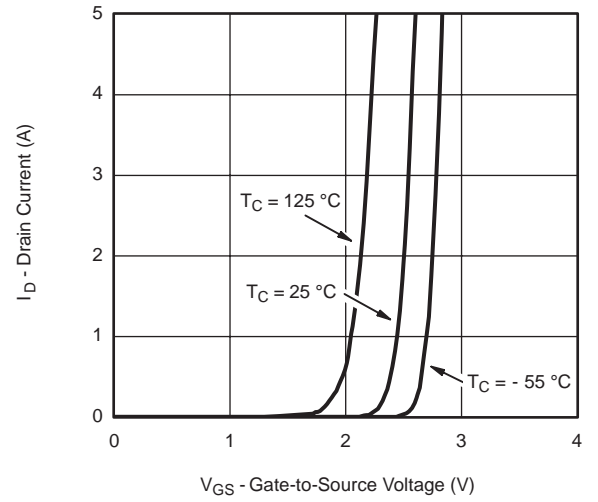

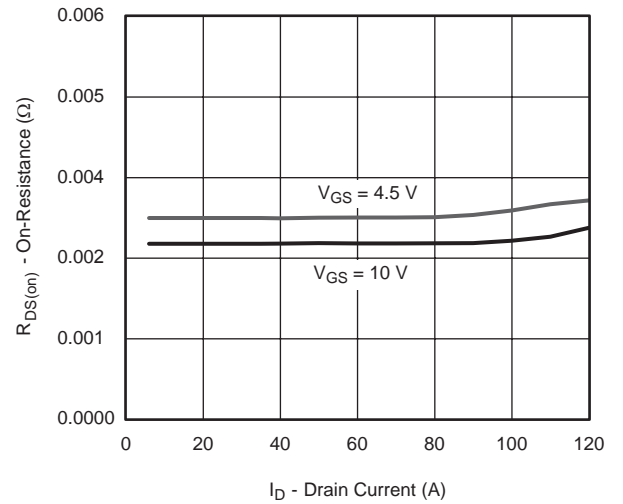

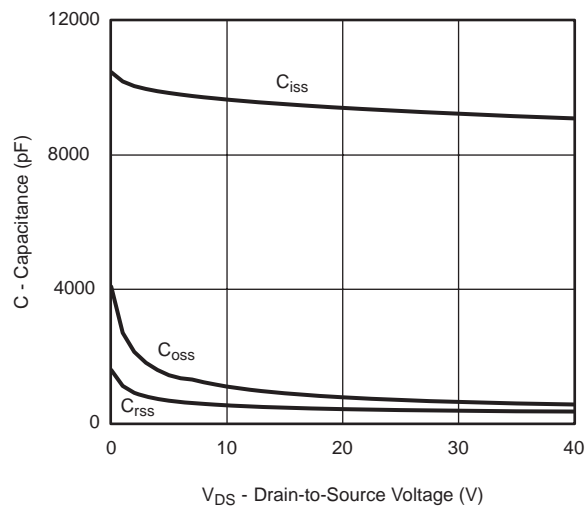

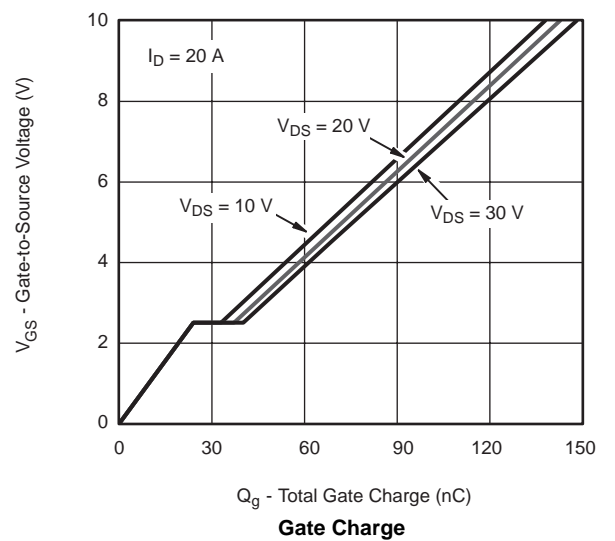
Transconductance

Capacitance

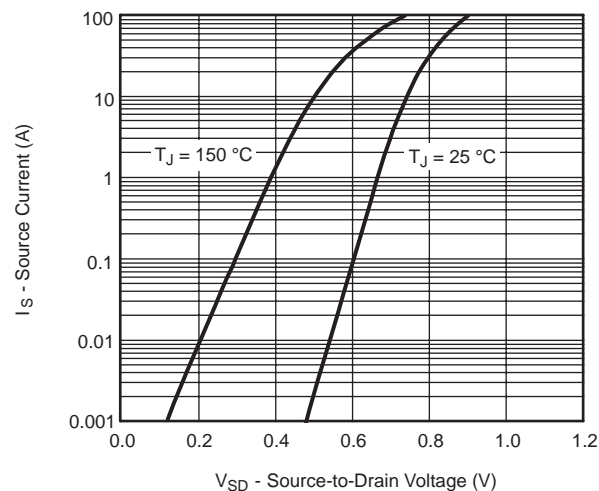

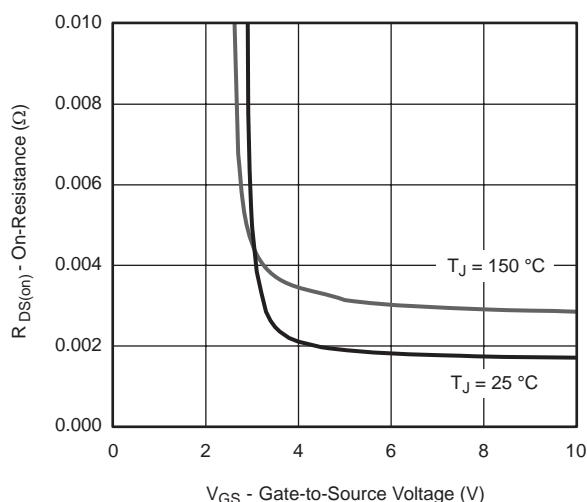

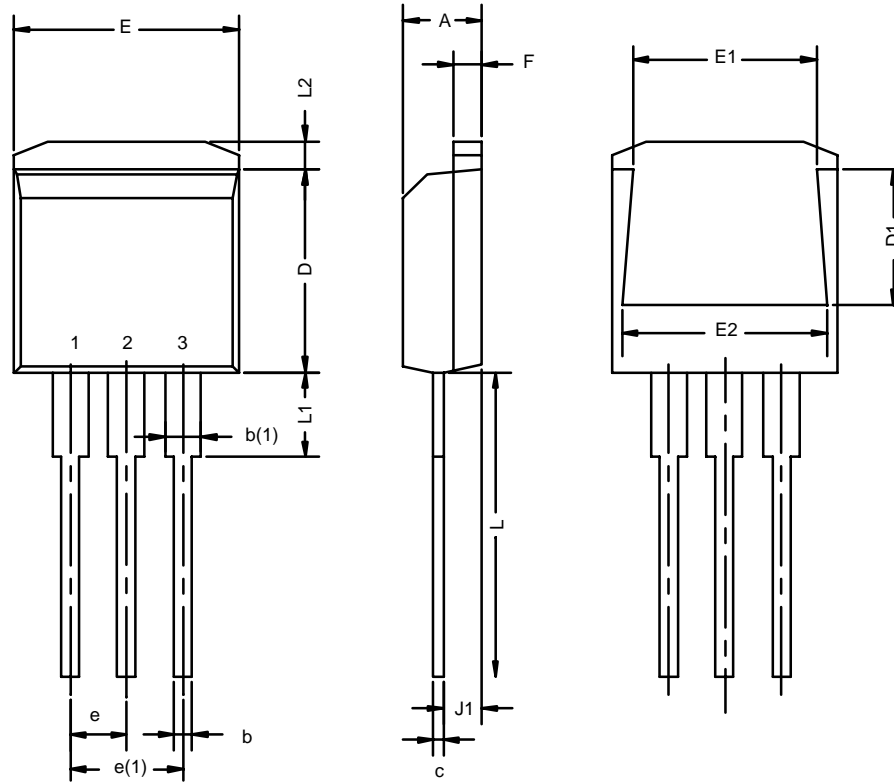
