









**On-Resistance vs. Gate-to-Source Voltage** 




Single Pulse Power, Junction-to-Ambient












### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)








Normalized Thermal Transient Impedance, Junction-to-Case
