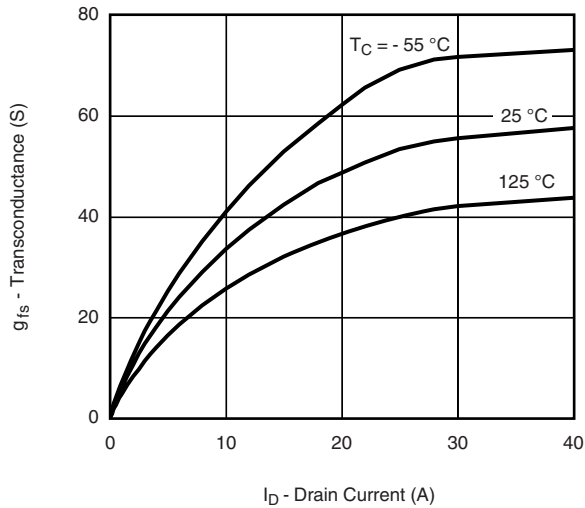

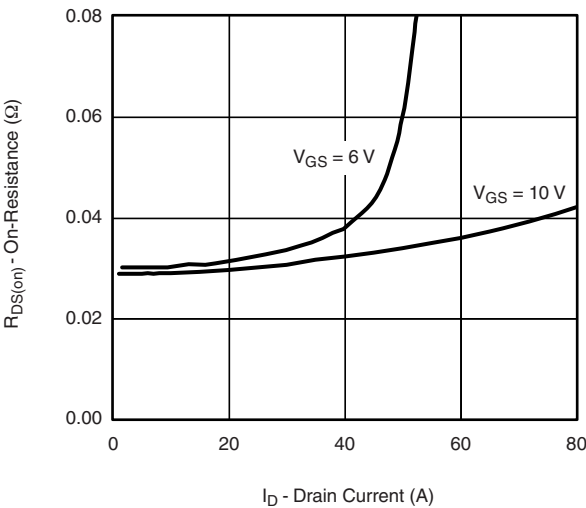

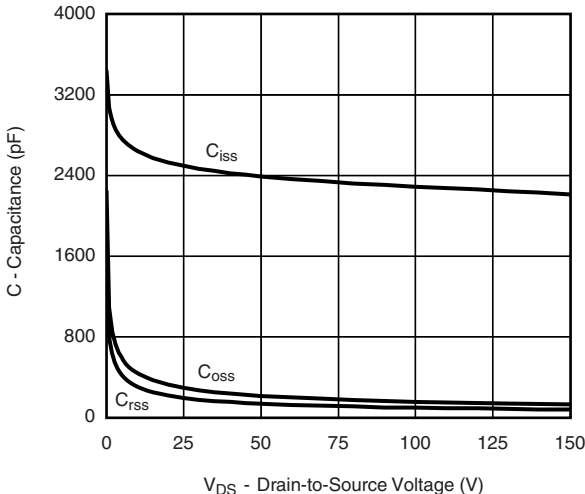

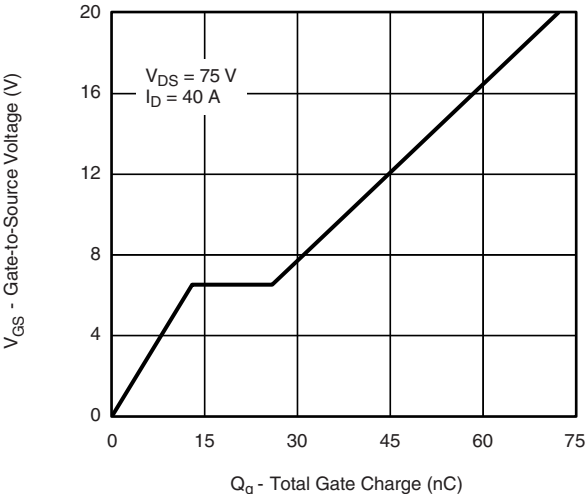

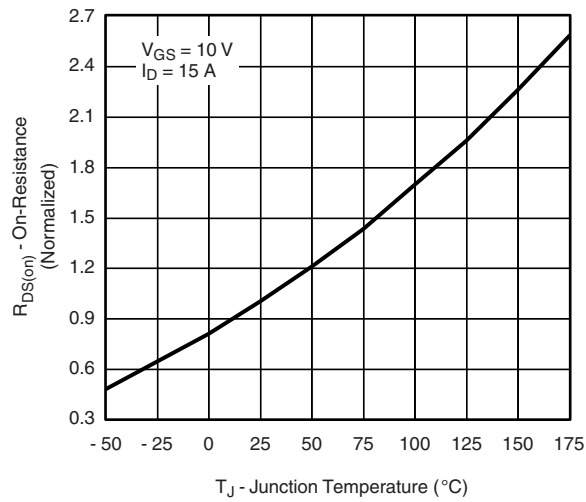
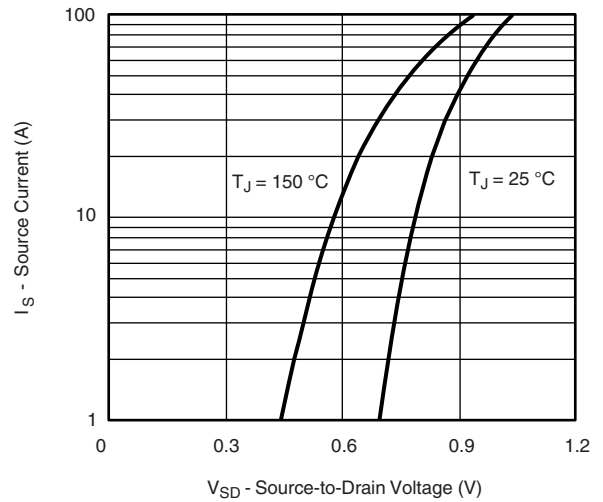
On-Resistance vs. Drain Current

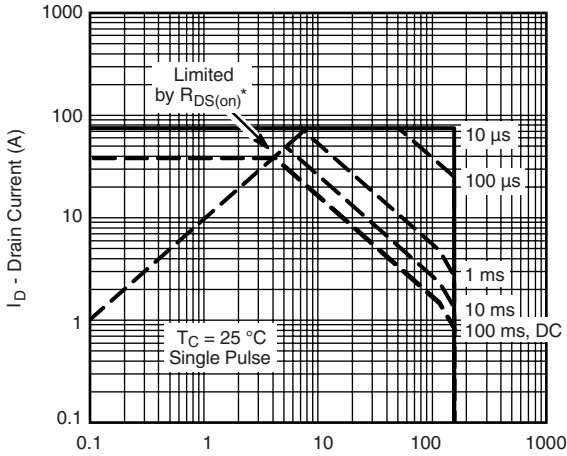

Maximum Avalanche and Drain Current vs. Case Temperature

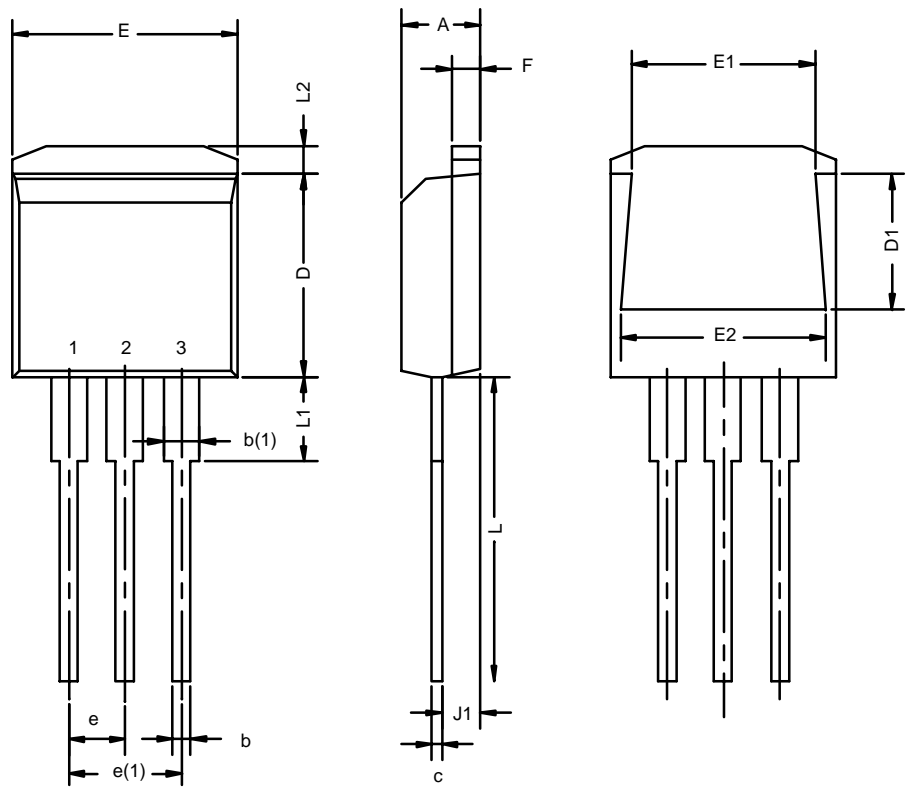
