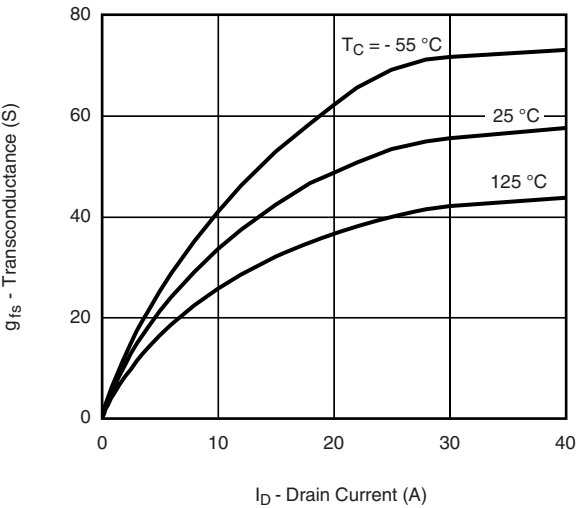

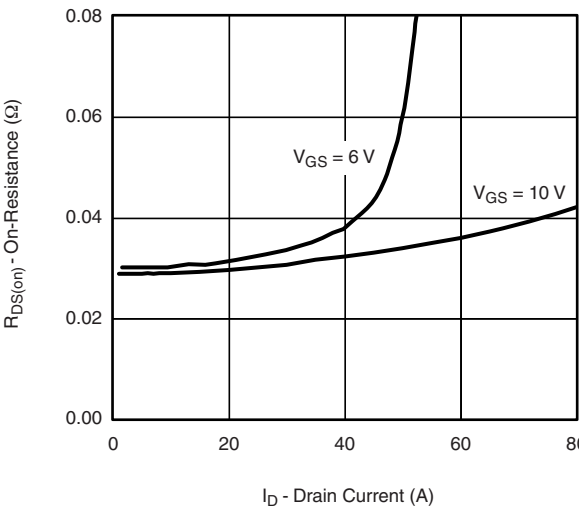

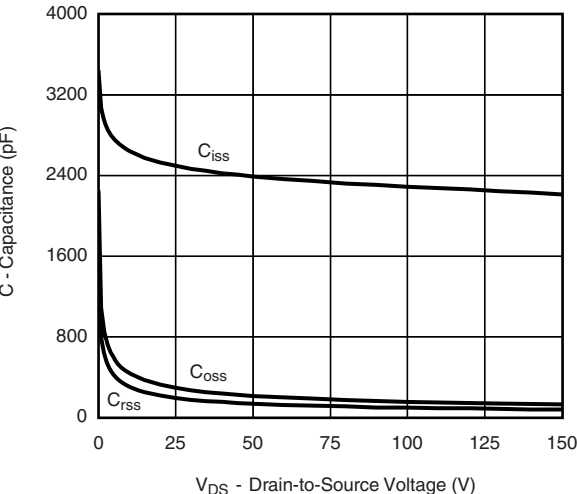
Transfer Characteristics



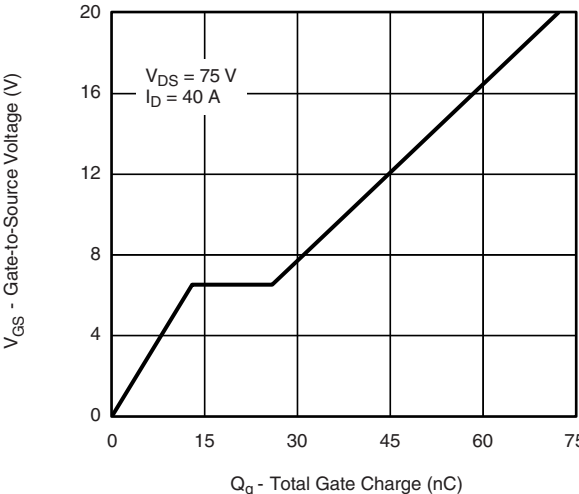
Transconductance



On-Resistance vs. Drain Current

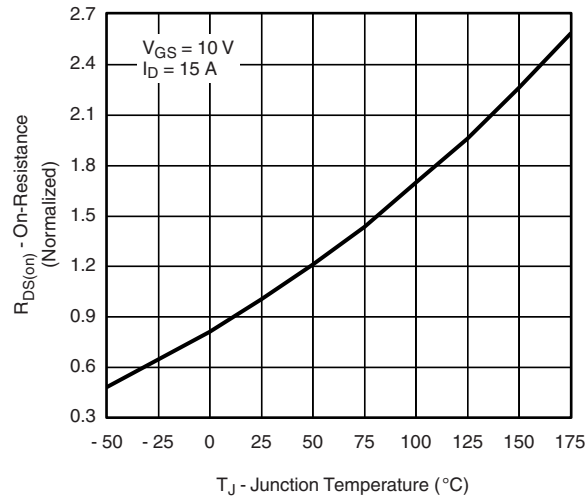


Capacitance

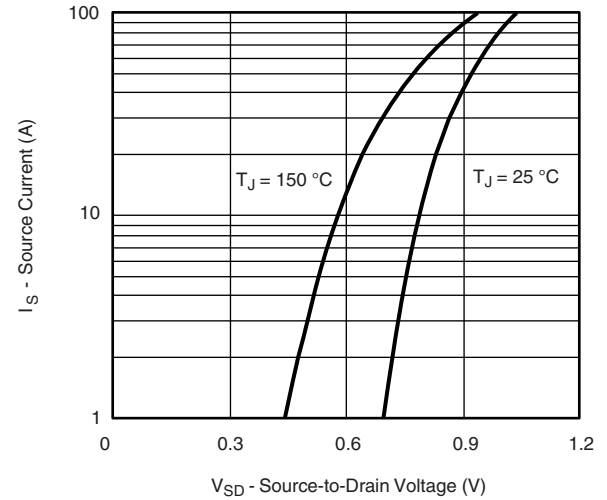

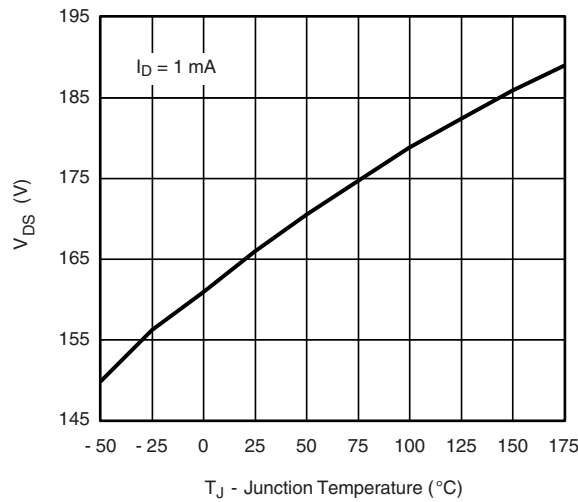

Source-Drain Diode Forward Voltage

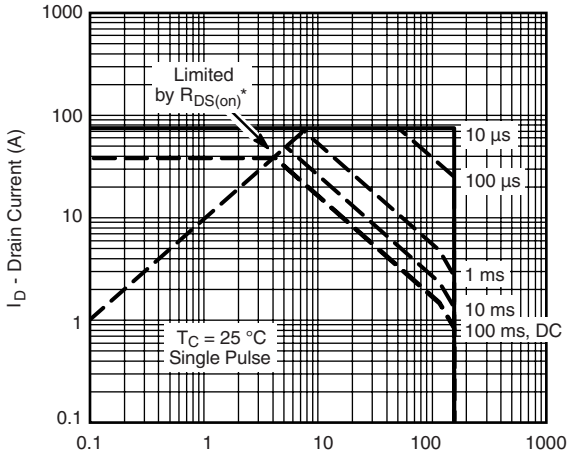


**Drain Source Breakdown
vs. Junction Temperature**

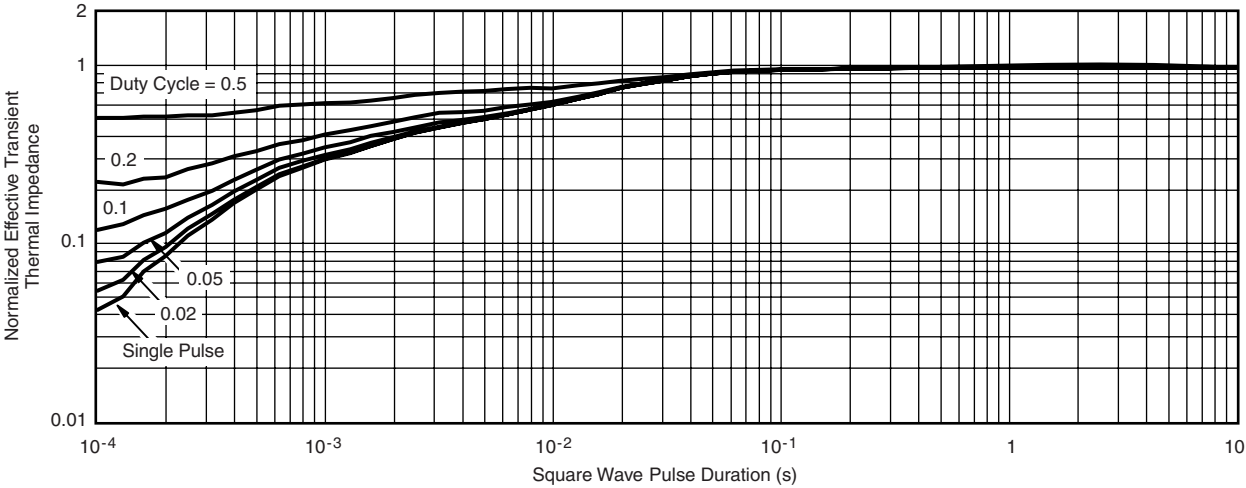

vs. Case Temperature

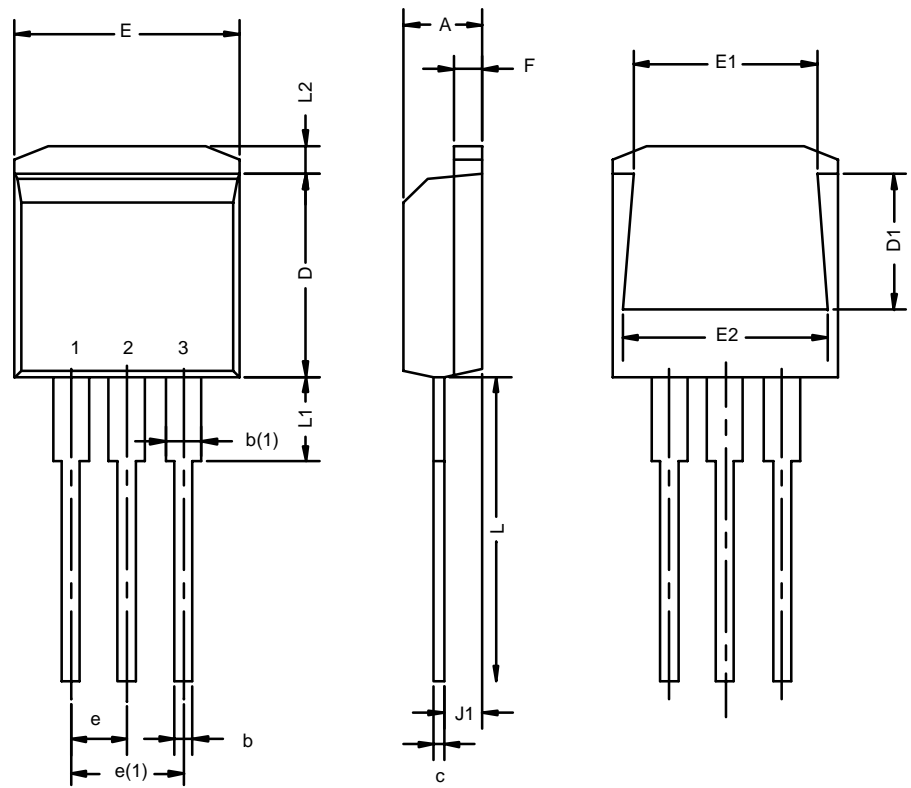


Safe Operating Area
